

## RESOLUTION No. B029-2022(G) PMO BATANGAS BIDS AND AWARDS COMMITTEE (PMOB-BAC)

WHEREAS, pursuant to Resolution No. A030-2022(G), the Philippine Ports Authority, Port Management Office of Batangas Bids and Awards Committee (PMOB-BAC) recommended bidding of the project: REPLACEMENT OF DEVICES FOR FIRE DETECTION ALARM SYSTEM AT ADMINISTRATION BUILDING in accordance with Section 53.9 of the 2016 Revised IRR of RA 9184, and was approved;

WHEREAS, the Request for Quotation (RFQ) for the aforesaid procurement was prepared;

WHEREAS, the Approved Budget for the Contract (ABC) for the aforementioned project in the amount of TWO HUNDRED FORTY EIGHT THOUSAND EIGHT HUNDRED PESOS (PHP 248,800.00), PHILIPPINE CURRENCY, was applied;

**WHEREAS,** applicable RFQ was posted at the PhilGEPS, PPA website and at the PPA Bulletin Board from **24-27 May 2022**;

WHEREAS, the applicable Request for Quotation (RFQ) was likewise distributed to local suppliers;

WHEREAS, in response to said RFQ, DMB FIRE & SAFETY ENTERPRISES INTERNATIONAL INC. submitted its bid/quotation before the deadline of 9:00 am, 27 May 2022;

WHEREAS, during examination of the documents of the bidders, it was found that all documents submitted by DMB FIRE & SAFETY ENTERPRISES INTERNATIONAL INC. were found complete and compliant with the requirements;

WHEREAS, after evaluation of the above documents, the PMOB-BAC verified/evaluated the submitted quotation of DMB FIRE & SAFETY ENTERPRISES INTERNATIONAL INC. and the offer was determined as follows, to wit:
