**WHEREAS**, pursuant to Resolution No. A046-2024(G), the PMOB-BAC recommended to the Port Manager the procurement for the **GARBAGE COLLECTION AND DISPOSAL AT PPA PMO BATANGAS FOR THE PERIOD OF 3 MONTHS CY 2024** through **Small Value Procurement** in accordance with Section 53.9 of the 2016 Revised IRR of RA 9184, and was approved;

**WHEREAS**, the Approved Budget for the Contract (ABC) for the aforementioned project in the amount of **NINE HUNDRED NINETY FIVE THOUSAND FIVE HUNDRED ELEVEN PESOS AND 62/100 (PHP 995,511.62)**, **PHILIPPINE CURRENCY** as per Purchase Request (PR) No. **BAT-1468-24** dated **02 July 2024**;

**WHEREAS**, the applicable Request for Quotation (RFQ) for the aforesaid procurement was prepared;

**WHEREAS**, applicable Request for Quotation (RFQ) was posted in the PhilGEPS, PPA Website and PMOB Bulletin Board on from **19 – 26 July 2024**;

**WHEREAS**, the aforesaid RFQ was likewise distributed to local suppliers;

**WHEREAS**, in response to said RFQ, **WASTECON INC.** submitted its bid/quotation before the deadline of **9:00 am, 26 July 2024**;

**WHEREAS**, during examination of the documents, **WASTECON INC.** failed to submit certified true copy of their Business Tax Return;

**NOW, THEREFORE**, for and in consideration of the foregoing, the PMOB Bids and Awards Committee (PMOB-BAC) hereby resolves, as it is hereby resolved, to declare failure of bidding and to recommend to the PPA-PMOB Port Manager the rebidding of the project: **Garbage Collection and Disposal at PPA PMO Batangas for the period of 3 months CY 2024** through **Small Value Procurement** in accordance with Section 53.9 of the 2016 Revised IRR of RA 9184.
