WHEREAS, the Philippine Ports Authority- Port Management Office of Palawan advertised/ posted the Invitation to Bid for the project NRP-PLW-01-2021 Repair of Damaged R.C. Wharf, Roro Ramp No. 2 and Back-Up Area, Port of Puerto Princesa, Palawan in the PhilGEPS and PPA websites, and at bulletin board of PMO- Palawan continuously for seven (7) days from September 4 to 10, 2021;
