RESOLUTION No. 23-2018

DECLARING THE BID OF LILY HILL TRADING FOR ITEM NOS. 1, 3, 4, 5, 6, 7, 9, 10 & 11 AS THE LOWEST CALCULATED AND RESPONSIVE BID AND RECOMMENDING TO THE PORT MANAGER THE AWARD OF THE CONTRACT;

DECLARING THE BID OF LJM INDUSTRIAL SAFETY PRODUCTS FOR ITEM NO. 8 AS THE LOWEST CALCULATED AND RESPONSIVE BID AND RECOMMENDING TO THE PORT MANAGER THE AWARD OF THE CONTRACT;

AND DECLARING FAILURE OF BIDDING FOR ITEM NOS. 2 & 12 AND RECOMMENDING TO THE PORT MANAGER THE CONDUCT OF SMALL VALUE PROCUREMENT.

WHEREAS, the Philippine Ports Authority, PMO Palawan posted the Invitation to Bid for the Procurement of Various Furniture, Fixtures and Equipment Under the Annual Equipment Procurement Program (AEPP) for 2018 in the PhilGEPS and PPA websites, and at BAC Bulletin Board of PMO- Palawan continuously for fourteen (14) days from November 21- December 04, 2018;

WHEREAS, in response to our postings/ invitations, two (2) suppliers responded namely;

1. Lily Hill Trading
2. LJM Industrial Safety Products

WHEREAS, before the scheduled time of submission of bids on December 04, 2018, these two (2) suppliers submitted their bids in sealed envelope. Lily Hill Trading submitted its bid and was received by the BAC on December 4, 2018 at 8:26 A.M while LJM Industrial Safety Product was received on December 4, 2018 at 8:25 AM;

WHEREAS, on the scheduled opening of bid on December 04, 2018 at 9:30 A.M., the BAC opened and evaluated the bid documents of the afore-named suppliers, and unanimously agreed and declared that the two (2) suppliers met and complied with the requirements;

WHEREAS, the BAC Chairperson read the financial bids, all bid prices are exclusive of VAT as follows:

WHEREAS, the BAC-TWG conducted detailed evaluation of bid per item on December 04, 2018. On their report submitted to the BAC on December 04, 2018, the BAC-TWG recommended that the submitted bid of Lily Hill Trading for Item Nos. 1, 3, 4, 5, 6, 7, 9, 10 & 11 and the submitted bid of LJM Industrial Safety Products for Item No. 8 be declared as the Lowest Calculated Bid and be subjected to post-qualification;

WHEREAS, on December 5, 2018 the BAC-TWG conducted post-qualification on the eligibility and technical documents as well as financial proposal of Lily Hill Trading and LJM Industrial Safety Products. Based on the results as presented in the Post-Qualification Evaluation Report, Lily Hill Trading was declared as the Lowest Calculated Responsive Bid for Items Nos. 1, 3, 4, 5, 6, 7, 9, 10 & 11 and LJM Industrial Safety Products for Item No. 8 and recommended the award of bid.


NOW, THEREFORE, We, the Members of the Bids and Awards Committee for the Procurement of Goods and Consultancy Services and for Engineering Projects (PMO-PALAWAN-BAC), hereby RESOLVE as it is hereby RESOLVED:

1. To declare the bid of Lily Hill Trading as the Lowest Calculated Responsive Bid for Items Nos. 1, 3, 4, 5, 6, 7, 9, 10 & 11 for the Procurement of Various Furniture, Fixtures and Equipment Under Annual Equipment Procurement Program (AEPP) for CY 2018 and to recommend to the Port Manager the award of the contract.
2. To declare the bid of LJM Industrial Safety Products as the Lowest Calculated Responsive Bid for Items No. 8 for the Procurement of Various Furniture, Fixtures and Equipment Under Annual Equipment Procurement Program (AEPP) for CY 2018 and to recommend to the Port Manager the award of the contract.

3. To declare a failure of bidding for Item nos. 2 & 12 as stated below with the approved budget of Two Hundred Twenty Eight Thousand Pesos (228,000.00) and to recommend to the Port Manager the conduct Small Value Procurement pursuant to Section 53.9 of R.A. 9184 and its Revised 2016 IRR.
4. To recommend the approval of the foregoing findings by the Port Manager.
