Declaring the Price Quotation of H.O. NOVELOSO SURVEYING as the Lowest and Responsive Quotation for the Consultancy Services for the Proposed Hydrographic and Topographic Survey of Port of Rizal, Rizal, Palawan and Recommending Approval Thereof and Recommending Award of Contract.

WHEREAS, the Philippine Ports Authority- Port Management Office of Palawan advertised/ posted the Invitation to Bid for the provision of consultancy services for the Proposed Hydrographic and Topographic Survey of Port of Rizal, Rizal, Palawan in the PhilGEPS and PPA websites, and at bulletin board of PMO- Palawan continuously for three (3) days from December 18-23, 2019;

WHEREAS, in response to the said advertisement/invitation, one (1) prospective bidder responded with the invitation, namely:

1.) H.O. NOVELOSO SURVEYING

WHEREAS, the bidder submitted their bid in sealed envelope with published deadline;

WHEREAS, on December 23, 2019 the Technical Bid of H.O. Noveloso Surveying was opened and passed the preliminary examination. After which, its Financial Bid was opened and has also passed the preliminary examination. The result of the Financial Bid is tabulated as follows:


