Declaring as Failure the Bidding of the project DOTr-LFP-PLW_01-2020 Roxas Port Development Project, Port of Roxas, Palawan (Re-bidding)

WHEREAS, the Philippine Ports Authority, PMO-Palawan advertised the Re Invitation to Bid for the DOTr-LFP-PLW_01-2020 Roxas Port Development Project, Port of Roxas, Palawan (Re-bidding) in PhilGEPS and PPA websites and at the bulletin board of PMO-Palawan continuously for seven (7) days from December 29, 2020, to January 5, 2021;

WHEREAS, in response to said advertisement, two (2) prospective bidders/contractors secured and purchased bid documents namely,

1. A.P. Consebido Construction
2. Harbor Shipping Services, Inc.

WHEREAS, both the contractors/bidders submitted their bids in a sealed envelope within the published deadline;

WHEREAS, at 9:41 A.M. on January 18, 2021, the Technical Bid of A.P. Consebido Construction was opened and failed the Eligibility and Technical/Project Requirements due to the following reasons:

Technical Documents

1. Erroneous entry/filling up of Form X - Statement of All On-Going Projects of the Prospective Bidder.

Project Requirements

1. The PRC license of the Project Engineer to be assigned to the contract be bid was expired.

WHEREAS, having been declared as "FAILED" by the BAC, Mr. John Lester Consebido, Representative of A.P. Consebido Construction has signified that they will no longer file a request for reconsideration. Their Technical Bid together with the unopened Financial Bid was returned and received by the representative of A.P. Consebido Construction.

WHEREAS, the Technical Bid of Harbor Shipping Services, Inc. was opened and failed the Legal Document Requirements due to the following reason,

Legal Documents

1. Mayor's/Business Permit of the bidder was expired and failed to attach the Official Receipt as proof that the bidder has applied for renewal within the period prescribed by the concerned local government as required by Section 23.1, a), ii) of the 2016 Revised IRR of RA 9184.

WHEREAS, having been declared as "FAILED" by the BAC, Mr. Emilio Dela Peña, Representative of Harbor Shipping Services, Inc. has signified that they will no longer file a request for reconsideration. Their Technical Bid together with the unopened Financial Bid was returned and received by the representative of Harbor Shipping Services, Inc.

NOW, THEREFORE, for in consideration of the foregoing premises, the PMO-Palawan Bids and Award Committee hereby resolves, as it hereby resolves, to declare the bidding of DOTr-LFP-PLW_01-2020 Roxas Port Development Project, Port of Roxas, Palawan (Re-bidding) a FAILURE;

RESOLVED FURTHER, to recommend to the Acting Port Manager of PMO-Palawan, the head of procuring entity, to conduct another competitive bidding as provided for in RA 9184 and its 2016 Revised IRR, the procurement of the contract of the subject project.


