Declaring the bid of GOLDRIDGE CONST. & DEV'T CORP. as the Single Calculated Responsive Bid for the project NRP-PLW-03-2021 Repair of Damaged R.C. Deck, R.C. Canal/Drainage System, Concrete Pavement and Paving Blocks at Back-up and Operational Areas, Port of Puerto Princesa, Palawan and Recommending Approval Thereof and Recommending Award of Contract

WHEREAS, the Philippine Ports Authority, PMO-Palawan re-advertised the Invitation to Bid for the project NRP-PLW-03-2021 Repair of Damaged R.C. Deck, R.C. Canal/Drainage System, Concrete Pavement and Paving Blocks at Back-up and Operational Areas, Port of Puerto Princesa, Palawan at PhilGEPS, PPA websites and at the bulletin board of PMO-Palawan continuously for twenty (20) days from February 4 – 23, 2022.

WHEREAS, in response to said advertisement, only one (1) prospective bidder/contractor secured and purchased bid documents namely GOLDRIDGE CONST. & DEV'T CORP.;

WHEREAS, the contractor/ bidder submitted their bids in sealed envelope within the published deadline;

WHEREAS, at 9:30 A.M. on February 23, 2022 the Technical Bid of GOLDRIDGE CONST. & DEV'T. CORP. was opened and passed the preliminary examination. After which, the Financial Bid was opened and also passed the preliminary examination, and the result of its Financial Bid is tabulated as follows:
