Declaring the Price Quotation of ALTERRA GEOMATICS & CONSTRUCTION as the Lowest and Responsive Quotation for the Consultancy for ECC Application for the Proposed Construction of Causeway, Back-up Area and RC Wharf with Roro Ramps, Port of San Fernando, El Nido, Palawan and Recommending Approval Thereof and Recommending Award of Contract.

WHEREAS, the Philippine Ports Authority- Port Management Office of Palawan advertised/ posted the Invitation to Bid for the provision of Consultancy for ECC Application for the Proposed Construction of Causeway, Back-up Area and RC Wharf with Roro Ramps, Port of San Fernando, El Nido, Palawan in the PhilGEPS and PPA websites, and at the bulletin board of PMO- Palawan continuously for seven (7) days from May 4-10, 2019;

WHEREAS, in response to the said advertisement, four (4) prospective bidders responded with the invitation, namely:

- 3.) ALTERRA GEOMATICS & CONSTRUCTION
- 4.) GREEN COLLAR CONSULTING SERVICES

WHEREAS, the contractors/bidders/suppliers submitted their bids in sealed envelope with published deadline;

WHEREAS, on May 29, 2019 the Technical Bids were opened and only two (2) bidders passed the preliminary examination. After which, the Financial Bids were opened and also passed the preliminary examination. The results of the Financial Bids are tabulated as follows:
