WHEREAS, the Philippine Ports Authority- Port Management Office of Palawan advertised/ posted the Invitation to Bid for the provision of consultancy services for the Proposed Hydrographic and Topographic Survey of Culion Port, Culion, Palawan in the PhilGEPS and PPA websites, and at the bulletin board of PMO- Palawan continuously for seven (7) days from May 4- 10, 2019;

WHEREAS, in response to the said advertisement/invitation, two (2) prospective bidders responded with the invitation, namely:

- 2.) H.O. NOVELOSO SURVEYING

WHEREAS, the contractors/bidders/suppliers submitted their bids in sealed envelope with published deadline;

WHEREAS, on May 29, 2019 the Technical Bids were opened and only one (1) bidder, H.O. Noveloso Surveying, passed the preliminary examination. After which, its Financial Bid was opened and has also passed the preliminary examination. The result of the Financial Bid is tabulated as follows:






