RESOLUTION DECLARING FAILURE OF BIDDING FOR THE PROJECT VARIOUS MAINTENANCE OF PORT PHYSICAL FACILITIES, PORT OF BROOKE'S POINT, BROOKE'S POINT, PALAWAN (MPF-PLW-03-2022)

WHEREAS, the Philippine Ports Authority, PMO-Palawan posted an Invitation to Bid for the project MPF-PLW-03-2022 Various Maintenance of Port Physical Facilities, Port of Brooke's Point, Brooke's Point, Palawan, in the website of the PPA, PhilGEPS and in the Bulletin Board of PMO-Palawan on 20 June 2022, continuously for seven (7) calendar days.

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is ₹ 1,159,720.30.

WHEREAS, during the opening of bids on 11 July 2022 at 9:30 A.M., no bids were received to be opened;

WHEREAS, the BAC, after a motion duly made and properly seconded, declared the bidding for the project MPF-PLW-03-2022 Various Maintenance of Port Physical Facilities, Port of Brooke's Point, Brooke's Point, Palawan, a failure, pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which provides to wit:

"35.1 The BAC shall declare the bidding a failure when:

a) No bids are received:

NOW THEREFORE, for and in consideration of the foregoing premises, the PMO-Palawan Bids and Awards Committee hereby RESOLVE as it is hereby RESOLVED to recommend the following:

- To recommend to the Head of the Procuring Entity that the bidding for the project MPF-PLW-03-2022 Various Maintenance of Port Physical Facilities, Port of Brooke's Point, Brooke's Point, Palawan, be declared a "failure" pursuant to Section 35.1 (a) of the 2016 Revised IRR of R.A. 9184.
- 2. To conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.
