A RESOLUTION DECLARING THE BID OF FOUR M BUILDERS AND AA LONGASA ELECTRONICS SERVICES (JV) AS THE SINGLE CALCULATED RESPONSIVE BID FOR THE REMAINING FIVE (5) ITEMS OF VARIOUS FURNITURE, FIXTURES AND EQUIPMENT UNDER THE ANNUAL EQUIPMENT PROCUREMENT PROGRAM FOR CY 2019 AND RECOMMENDING APPROVAL THEREOF AND RECOMMENDING AWARD OF THE CONTRACT

WHEREAS, the Philippine Ports Authority, PMO-Palawan, posted its Invitation to Bid for five (5) items of Furniture, Fixtures and Equipment under its Annual Equipment Procurement Program (AEPP) for CY 2019, at the websites of Philippine Ports Authority Head Office and PhilGEPS, and at the PMO Bulletin Board situated at conspicuous place, for eight days from May 29 to June 5, 2020;

WHEREAS, in response to the said advertisement/invitation for negotiation. Only one (1) prospective bidder responded with the invitation, namely:

1.) Four M Builders and AA Longasa Electronics Services (JV)

WHEREAS, the bidder submitted their bids in sealed envelope before the scheduled opening of bids on June 22, 2020 at 9:30 A.M;

WHEREAS, the Technical Bid (Eligibility and Technical Requirements) of Four M Builders and AA Longasa Electronics Services (JV) was opened and passed the preliminary examination. After which, the Financial Bids was opened and also passed the preliminary examination, and the result of its Financial Bid is tabulated as follows:

NOW, THEREFORE, We, the Members of the Bids and Awards Committee for the Procurement of Goods and Consultancy Services and for Engineering Projects (PMO-PALAWAN-BAC), hereby RESOLVE as it is hereby RESOLVED:

- a) To declare Four M Builders and AA Longasa Electronics Services (JV) as the bidder with the Single Calculated Responsive Bid for the remaining five (5) items of various furniture, fixtures and equipment under the Annual Equipment Procurement Program for CY 2019;
 - b) To recommend for approval by the Acting Port Manager/Head of the Procuring Entity (HOPE) of PMO- Palawan the foregoing findings; and
- c) To recommend award of contract of the subject project to Four M Builders and AA Longasa Electronics Services (JV) in its submitted bid amount of Php 4,100,040.00
