**Declaring the bid of CMCS BUILDERS as the Single Calculated Responsive Bid for the project MPF-PLW-01-2021 Various Maintenance of Port Physical Facilities, Port of Puerto Princesa, Palawan and Recommending Approval Thereof and Recommending Award of Contract.**

WHEREAS, the Philippine Ports Authority- Port Management Office of Palawan advertised/ posted the Invitation to Bid for the project MPF-PLW-01-2021 Various Maintenance of Port Physical Facilities, Port of Puerto Princesa, Palawan in the PhilGEPS and PPA websites, and at bulletin board of PMO- Palawan continuously for seven (7) days from June 30 to July 06, 2021;

WHEREAS, in response to the said advertisement, three (3) prospective bidders bought the Official Bid Documents at 5,000.00 each:

- 1). ORIENT STAR CONSTRUCTION, INC.
- 2). E.M. ABIN TRADING & CONSTRUCTION
- 3). CMCS BUILDERS

WHEREAS, on July 19, 2021, Orient Star Construction, Inc. submitted a letter withdrawing its intention to participate in the bidding;

WHEREAS, on the scheduled Submission and Opening of Bids, only (1) contractor/ bidder submitted their bids, namely:

- 1). CMCS BUILDERS;

WHEREAS, E.M. ABIN TRADING & CONSTRUCTION did not submit any letter to express its intention not to participate in the bidding;

WHEREAS, at 9:30 A.M. on July 21, 2021 the Technical Bid of CMCS BUILDERS was opened and passed the preliminary examination. After which, the Financial Bid was opened and also passed the preliminary examination, and the result of its Financial Bid is tabulated as follows:

- c) To recommend award of contract of the subject project to CMCS BUILDERS in its submitted bid amount of Php 3,482,766.18.
