**DECLARING THE BID OF EMCOR, INC FOR ITEM NOS. 5, 6, 7, 8 & 10 AS THE LOWEST
CALCULATED AND RESPONSIVE BID AND RECOMMENDING TO THE ACTING PORT
MANAGER THE AWARD OF THE CONTRACT;**

**AND DECLARING FAILURE OF BIDDING FOR ITEM NOS. 1, 2, 3, 4 & 9 AND
RECOMMENDING TO THE ACTING PORT MANAGER TO CONDUCT RE-BIDDING;**

WHEREAS, the Philippine Ports Authority, PMO Palawan posted the Invitation to Bid for the Procurement of Various Furniture, Fixtures and Equipment Under the Annual Equipment Procurement Program (AEPP) for CY 2019 in the PhilGEPS and PPA websites, and at BAC Bulletin Board of PMO- Palawan continuously for Seven (7) days from August 20- 26, 2019;

WHEREAS, in response to our postings/ invitations, three (3) suppliers responded namely;

1. Emcor, Inc.
2. Asahi Design Center Inc
3. LJM Fire Protection Services and Trading

WHEREAS, before the scheduled time of submission of bids on September 09, 2019, these three (3) suppliers submitted their bids in sealed envelope. Emcor, Inc submitted its bid and was received by the BAC on September 09, 2019 at 7:15 A.M, while Asahi Design Center Inc. on September 09, 2019 at 7:21 A.M and LJM Fire Protection Services and Trading was received on September 09, 2019 at 7:42 A.M, respectively.

WHEREAS, on the scheduled opening of bids on September 10, 2019 at 9:00 A.M., the Bids and Awards Committee opened and evaluated the bid documents of the aforementioned suppliers and unanimously agreed and declared that the two (2) suppliers, namely Emcor, Inc and Asahi Design Center Inc met and complied with the requirements.

WHEREAS, the BAC unanimously agreed and declared that the Technical Bid of LJM Fire Protection Services and Trading failed to comply with the requirements. The Financial Bid was not opened.

WHEREAS, the BAC Vice-Chairperson read the financial bids of Emcor, Inc and Asahi Design Center Inc, all bid prices are exclusive of VAT as follows:

WHEREAS, the BAC-TWG conducted detailed evaluation of bid per item on September 10, 2019. On their report submitted to the BAC on September 10, 2019, the BAC-TWG recommended that the submitted bid of Emcor, Inc. for Item Nos. 5, 6, 7, 8 & 10 be declared as the Lowest Calculated Bid and be subjected to post-qualification.

WHEREAS, The BAC- TWG, upon careful examination and detailed evaluation of the technical bid, declared Asahi Design Center Inc disqualified.

WHEREAS, on September 13, 2019 the BAC-TWG conducted post-qualification on the eligibility and technical documents as well as financial proposal of Emcor, Inc. Based on the results as presented in the Post-Qualification Evaluation Report, Emcor, Inc was declared as the Lowest Calculated Responsive Bid for Items Nos. 5, 6, 7, 8 & 10 and recommended the award of bid.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee for the Procurement of Goods and Consultancy Services and for Engineering Projects (PMO-PALAWAN-BAC), hereby RESOLVE as it is hereby RESOLVED:

1. To declare the bid of Emcor, Inc. as the Lowest Calculated Responsive Bid for Items Nos. 5, 6, 7, 8 & 10 amounting to Two Million One Hundred Twenty- Two Thousand Seven Hundred Eighty pesos (P 2,122,780.00) for the Procurement of Various Furniture, Fixtures and Equipment Under Annual Equipment Procurement Program (AEPP) for CY 2019 and to recommend to the Acting Port Manager the award of the contract.
2. To declare a failure of bidding for Item Nos. 1, 2, 3, 4 & 9 as stated below with the approved budget of Four Million One Hundred Twenty- Five Thousand pesos (P 4,125,000.00) and to recommend to Acting Port Manager of PMO-Palawan, as the Head of Procuring Entity, to conduct a re-bidding with re-advertisement and/or posting of the subject project, as provided for in RA 9184 and its 2016 Revised IRR.
3. To recommend the approval of the foregoing findings by the Acting Port Manager.
