**A RESOLUTION DECLARING A SECOND FAILURE OF BIDDING FOR
VARIOUS FURNITURE, FIXTURES AND EQUIPMENT UNDER THE ANNUAL
EQUIPMENT PROCUREMENT PROGRAM FOR CY 2019;**

**AND RECOMMENDING TO THE ACTING PORT MANAGER TO CONDUCT
NEGOTIATED PROCUREMENT;**

WHEREAS, on August 20, 2019, the Philippine Ports Authority, PMO-Palawan, posted its Invitation To Bid for ten (10) items of Furniture, Fixtures and Equipment under its Annual Equipment Procurement Program (AEPP) for CY 2019, at the websites of Philippine Ports Authority Head Office and PhilGEPS, and at the PMO Bulletin Board situated at conspicuous place, for seven days;

WHEREAS, per Resolution No. 11-2019 dated 13 September 2019, the PMO-Palawan-BAC recommended to the Port Manager, this PMO, and subsequently issued Notices of Awards for the five (5) items of furniture, fixtures and equipment to the winning bidders, and, declared a failure of bidding for the following remaining five (5) items;

WHEREAS, on September 26, 2019, PPA, PMO-Palawan re-posted the Invitation To Bid for the re-bidding of five (5) items of Furniture, Fixtures and Equipment under the Annual Equipment Procurement Program for CY 2019 in the PPA Website, the PhilGEPS and at a conspicuous place at the premises of the Philippine Ports Authority-PMO Palawan, continuously for seven (7) days ;

WHEREAS, two (2) suppliers responded to said advertisement within the prescribed period, namely:

- 1.) Audacious Site Enterprises
- 2.) AGP Industrial Sales & Services

WHEREAS, on October 21, 2019 at 9:00 A.M., the bid documents of 2 suppliers were opened and evaluated.

WHEREAS, the BAC unanimously agreed and declared that the Technical Bids of Audacious Site Enterprises and AGP Industrial Sales & Services failed to comply with the requirements. The Financial Bids were not opened.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee for the Procurement of Goods and Consultancy Services and for Engineering Projects (PMO-PALAWAN-BAC), hereby RESOLVE as it is hereby RESOLVED:

1. To declare a SECOND FAILURE OF BIDDING for the remaining five (5) items of various furniture, fixtures and equipment under the Annual Equipment Procurement Program for CY 2019;
2. To RECOMMEND to the Acting Port Manager of PMO-Palawan, as the Head of Procuring Entity the conduct of Negotiated Procurement for the remaining five (5) items as above-enumerated, as provided for in Sub-Section 35.5 of the IRR of RA 9184 and its 2016 Revised IRR which states that, " Should there occur a second failure of bidding, the Procuring Entity concerned may resort to negotiated procurement, as provided for in Section 53.1 of this IRR;
