**A RESOLUTION DECLARING A FAILURE OF BIDDING FOR NEGOTIATED
PROCUREMENT FOR THE REMAINING FIVE (5) ITEMS OF VARIOUS
FURNITURE, FIXTURES AND EQUIPMENT UNDER THE ANNUAL
EQUIPMENT PROCUREMENT PROGRAM FOR CY 2019**

WHEREAS, the Philippine Ports Authority, PMO-Palawan, posted its Invitation to Bid for five (5) items of Furniture, Fixtures and Equipment under its Annual Equipment Procurement Program (AEPP) for CY 2019, at the websites of Philippine Ports Authority Head Office and PhilGEPS, and at the PMO Bulletin Board situated at conspicuous place, for three days from October 22-24, 2019;

WHEREAS, in response to the said advertisement/invitation for negotiation. Two (2) prospective bidders responded with the invitation, namely:

- 1.) Audacious Site Enterprises
- 2.) AGP Industrial Sales & Services, Inc.

WHEREAS, the bidders submitted their bids in sealed envelope before the scheduled opening of bids on November 12, 2019 at 9:00 A.M;

WHEREAS, the BAC unanimously agreed to disqualify Audacious Site Enterprise due to non-attendance to the Negotiated Conference held on October 28, 2019, not in accordance with the agreement of the BAC that only bidders who attended the Negotiated Conference will be allowed to submit their bids;

WHEREAS, the Technical Bid (Eligibility and Technical Requirements)of AGP Industrial Sales & Services, Inc. was opened and passed the preliminary examination. After which, the Financial Bids was opened and also passed the preliminary examination, and the result of its Financial Bid is tabulated as follows:

WHEREAS, the BAC-TWG conducted detailed evaluation of bid per item on November 12, 2019 at 2:00 P.M. On their report submitted to the BAC, the BAC-TWG recommended that the submitted bid of AGP Industrial Sales & Services, Inc. for five (5) items be declared as the Single Calculated Bid and be subjected to post-qualification.


WHEREAS, on November 19, 2019 the BAC-TWG conducted post-qualification on the eligibility and technical documents as well as financial proposal of AGP Industrial Sales and Services, Inc. Based on the results as presented in the Post-Qualification Evaluation Report, AGP Industrial Sales and Services, Inc. was declared post disqualified due to failure to present the Post-Qualification Documents as prescribed with RA 9184 and its 2016 Revised IRR and Latest GPPB Issuance;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee for the Procurement of Goods and Consultancy Services and for Engineering Projects (PMO-PALAWAN-BAC), hereby RESOLVE to declare a FAILURE OF BIDDING for Negotiated Procurement for the remaining five (5) items of various furniture, fixtures and equipment under the Annual Equipment Procurement Program for CY 2019;
