WHEREAS, the Philippine Ports Authority – Port Management Office of Marinduque/Quezon advertised/posted the Invitation to Bid for the Repair of Damaged Concrete Pavement, Drainage System and Perimeter Fence, Port of Balanacan, Marinduque in the PhilGEPS and PPA websites and at the bulletin board of PMO Marquez continuously for seven days from May 3 to 9, 2017;

WHEREAS, in response thereto, two (2) prospective bidders purchased bidding documents, namely:

- 2. R.V. Laborte Builders

WHEREAS, the deadline of submission/receipt of bids and the opening of bids was May 23, 2017 at 9:00 A.M.;

WHEREAS, the above-mentioned contractors submitted their bids before the published deadline:

WHEREAS, starting at 9:00 A.M. on May 23, 2017, the bids were opened and the results were as follows:

First to be opened was the bid of Infra Builders & Sellers, Phils.

- Next to be opened was the bid of R.V. Laborte Builders. After preliminary examination of its Technical Bid, the same was declared "failed/disqualified" due to the following deficiency, to wit:
  - All copies of the Technical Bid, including the original, were not properly book bound and had no hard cover as required.

Item XI of the Instruction for Submission of Bids and Item VIII of the Instruction for Eligibility Requirements clearly state that "the original and copies of the Technical and Financial Bids shall be properly book bound with hard cover. Paper bound, screw bound, ring bound, combo bound, fastener bound or stapler bound, or with loose page(s), are not acceptable. Failure to comply with this requirement shall be ground for disqualification/failure of bid."

In view of the "failure" of the Technical Bid of R.V. Laborte Builders, its Financial Bid was left unopened and the same was returned to and received by its representative after the latter signified their intention not to file a motion/request for reconsideration.

WHEREAS, the detailed evaluation of bids conducted at 3:00 P.M. on May 23, 2017 resulted in the following:

c) To recommend award of contract of the subject project to Infra Builders & Sellers, Phils. in its submitted bid in the amount of PHP 13,145,631.65.
