WHEREAS, the Philippine Ports Authority – Port Management Office of Marinduque/Quezon advertised/posted the Invitation to Bid for the Repair of RoRo Terminal Fee (RRTF) Facility at Gate 2, Port of Lucena, Lucena City in the PhilGEPS and PPA websites and at the bulletin board of PMO Marquez continuously for seven (7) days from October 4 to 10, 2017;

WHEREAS, the deadline of submission/receipt of bids and the opening of bids was October 24, 2017 at 9:00 A.M. and 10:30 A.M., respectively;

WHEREAS, *Shamara Builder and Construction Supply Inc.* submitted its bid, in sealed envelope, on October 23, 2017 at 4:25 P.M.;

WHEREAS, at 10:30 A.M. on October 24, 2017, the Technical and Financial Bids of *Shamara Builder and Construction Supply Inc.* were opened and passed the preliminary examination, and the result of its Financial Bid is tabulated as follows:

4. Establish a world-class port operation that is globally competitive adding value to the country's image and reputation.






