A Resolution Recommending Award of Contract for "Garbage Collection and Disposal at Baseport, CY 2019" to J.S Layson Co. & Inc. "

WHEREAS, BAC Resolution No. 010-2019 declares the bid of J.S Layson & Co. Inc as Single Responsive Bid for the project" Garbage Collection and Disposal at Baseport, CY 2019 as prescribed under Section 36 of 2016 Revised IRR of RA 9184;


WHEREAS, after post-qualification of the submitted documents, taking into account its legal, technical, experience and contractor performance, equipment and financial requirements, the Committee found that J.S Layson Co. & Inc has the single calculated responsive bid and is sufficiently capable to undertake and execute the project;


WHEREAS, BAC Resolution No. 011-2019 "A Resolution Holding the Recommendation of Award of Contract for "Garbage Collection and Disposal at Baseport, CY 2019 to J.S Layson Co. & Inc. pending Approval of Annual Procurement Plan (APP)", suspends the issuance of the Notice of Award (NOA) and adopt the maximum calendar days allowed for activities for Post-qualification and approval of Resolution/Issuance of Notice of Award in anticipation of the approval of the Annual Procurement Plan (APP);

WHEREAS, Memorandum from the Manager of PCMD with subject Annual Procurement Plan state that "The term PLOPEP and APOP was adopted from the previous Revised Delegation of Authority and Memorandum Order No. 01-2000";a) "The procedure/guidelines in the preparation/evaluation of the Annual Procurement Plan for infrastructure project is the same with the preparation being adopted for approval of Approved Program of Projects, the Engineering Office considers this terminology as one or the same" ;b) "Thus, the approved APOP may be consider as the PMO's annual procurement plan/program for the year"; "Likewise, may we recommend/suggest that the term Annual Procurement Plan be considered/adopted for the coming year.";


