MORALES, the COMMITTEE RESOLVED, as it is HEREBY RESOLVED to accept the Bid Tendered by HUC Merchandising, as the *Single Calculated Bid* for the *SUPPLY AND DELIVERY OF FRESHWATER FOR ICPC AND OTHER FACILITIES FOR CY2018*” in the amount of **ONE MILLION FOUR HUNDRED TEN THOUSAND FIVE HUNDRED PESOS ONLY (Php1,410,500.00)** subject to Bid Evaluation and Post-Qualification Process.

WHEREAS, the subsequent detailed evaluation of bid shows no corrections on the bid amount as read;



- b) To recommend for the approval of the award by the Port Manager of PMO-Panay/Guimaras based on the above findings and declaration.
