A Resolution declaring the bid of F. Gurrea Construction Inc. as the lowest responsive bid for the project "Repair of Apron and Pavement at Fort San Pedro, Iloilo City"

WHEREAS, opening of bids for the above project with Approved Budget for the Contract to be Bid (ABC) of Twenty Nine Million, Six Hundred Seventy-Eight Thousand, Two Hundred Sixty-Eight Pesos and 50/100 (P29, 678,268.50) was conducted at the Conference Room, 2nd Floor- PPA Administration Building, Iloilo Commercial Port Complex, Iloilo City on September 3, 2018 at nine o' clock in the morning;

WHEREAS, F. Gurrea Construction Inc. declared as the lowest responsive bid for the above stated project;

WHEREAS, after all documentary requirements for the first envelope were submitted, F. Gurrea Construction Inc. was declared eligible and evaluation of the Financial Documents revealed that F. Gurrea Construction Inc. has the lowest responsive bid of **Twenty-Nine Million, Six Hundred Twenty-Seven Thousand, Three Hundred Seventy-One Pesos and 79/100 (P29, 627,371.79)** which is lower by 0.17% of the approved ABC;


