BAC-EP RESOLUTION NO. 11-2018



A Resolution declaring the bid of Chedmaryl Construction & Supplies as the Lowest Calculated Bid for the project "Repair of Damaged Pavement, Perimeter Fence and Bulkhead at Port of Jordan, Guimaras".

WHEREAS, opening of bids for the above project with Approved Budget for the Contract to be Bid (ABC) of ***Eleven Million, Eight Hundred Seventy Nine Thousand, Four Hundred Forty-Two Pesos and 0 4/100 (P11, 879,442.04)*** was conducted at the Conference Room, 2nd Floor- PPA Administration Building, Iloilo Commercial Port Complex, Iloilo City on July 5, 2018 at nine o' clock in the morning;

WHEREAS, ***Chedmaryl Construction & Supplies*** was declared as lowest calculated bid for the above stated project;

WHEREAS, after all documentary requirements for the first envelope were submitted, ***Chedmaryl Construction & Supplies*** was declared eligible and evaluation of the Financial Documents revealed that Chedmaryl Construction & Supplies has the lowest responsive bid of ***Eleven Million, Eight Hundred Twenty-Eight Thousand, Eight Hundred Seventy-Seven Pesos and 31/100 (P11, 828,877.31)*** which is lower by 0.42% of the approved ABC;

NOW, THEREFORE, the PMO-Panay/Guimaras BAC-EP hereby resolves to declare the bid of ***F Chedmaryl Construction & Supplies*** as the lowest calculated responsive bid for ***"Repair of Damaged Pavement, Perimeter Fence and Bulkhead at Port of Jordan, Guimaras"***, in the amount of ***Eleven Million, Eight Hundred Twenty-Eight Thousand, Nine Hundred Sixty-Seven Pesos and 70/100 (P11, 828,967.70)***.






