




WHEREAS, opening of bids for the above project with Approved Budget for the Contract to be Bid (ABC) of Four Million Two Hundred Forty-Nine Thousand, Seven Hundred Ninety-Seven Pesos and 00/100 (P 4,249,797.00) was conducted at the Conference Room, 2nd Floor- PPA Administration Building, Iloilo Commercial Port Complex, Iloilo City on May 31, 2018 at nine o' clock in the morning;

WHEREAS, *E.M Paule Construction & Trading Inc.* was declared as lone bidder for the above stated project;

WHEREAS, after all documentary requirements for the first envelope were submitted, E.M Paule Construction & Trading Inc. was declared eligible and evaluation of the Financial Documents revealed that E.M Paule Construction & Trading Inc. has the single responsive bid of Four Million One Hundred Sixty-Five Thousand Two Hundred Forty-Two Pesos and 07/100 (P 4,165,242.07) which is lower by 0.98% of the approved ABC;

NOW, THEREFORE, the PMO-Panay/Guimaras BAC-EP hereby resolves to declare the bid of *E.M Paule Construction & Trading Inc.* as the lowest calculated bid for ***"Repair and Maintenance of Port Facilities at PMO-Panay/Guimaras, CY 2018"***, in the amount of ***Four Million One Hundred Sixty-Five Thousand Two Hundred Forty-Two Pesos and 07/100 (P 4,165,242.07)***.




