

RESOLUTION NO. 2018 - 011

(Declaring **SCRB** and Recommending Award of Contract to **L.N.R. CONSTRUCTION**)

WHEREAS, the **Philippine Ports Authority, Port Management Office-Eastern Leyte/Samar** advertised the Invitation to Apply for Eligibility and to Bid for the project **Repair of Damaged Rubber Dock Fenders at Terminal Ports, Port of Catbalogan, Borongan, San Jose, San Isidro, and Guiuan, Samar (NRP-ELS-04-18)** with an Approved Budget for the Contract (ABC) of **Php 17,015,376.46** in the **Manila Times** on **October 10, 2018** and posted the same in the **Philippine Ports Authority** website, the **PhilGEPS**, and at conspicuous places continuously for seven (7) days, to wit;

- 1) PMO-Tacloban Bulletin Board
- 2) Terminal Management Offices - Catbalogan, San Isidro, Guiuan, Borongan and San Jose

WHEREAS, in response to the said advertisement, only **one (1)** prospective bidder, **L.N.R. CONSTRUCTION** purchased and submitted bid documents;

WHEREAS, it passed the preliminary examination of bids on **October 29, 2018**, with a submitted bid price as follows:

WHEREAS, the detailed evaluation of its bid conducted on **October 31, 2018** shows the following :

WHEREAS, on **November 5, 2018**, the Technical Working Group (TWG) conducted post-qualification on **L.N.R. Construction**;

WHEREAS, upon deliberation conducted on **November 9, 2018**, **L.N.R. Construction** was found to be responsive to all the legal, technical, and financial requirements;

WHEREFORE, the BAC-EP resolves that L.N.R. CONSTRUCTION be, as it is hereby

- a) Declared as the Bidder with the Single Calculated and Responsive Bid pursuant to Sec.36(a), Rule X of the IRR of RA 9184;
- b) Recommended to the Head of Procuring Entity (HOPE) for the award of the contract at its submitted bid price of Php 17,007,024.29 which is equal to its calculated bid price of Php 17,007,024.29, consistent with Sec.34.4, Rule X of the IRR of RA 9184


