



BAC Resolution Declaring LCRB and Recommending Approval

RESOLUTION NO. EP003-2019

WHEREAS, the Philippine Ports Authority, Port Management Office - Negros Occidental/Bacolod/Banago-BREDCO advertised the Invitation to Bid of the **REPAIR OF BANAGO PORT UNDERDECK, Port of Banago, Bacolod City (NRP-NBB-08-19), Negros Occidental with an ABC of Php 30,111,037.14**, posted in the Philippine Ports Authority website, the PhilGEPS and in the conspicuous places at the following premises continuously for 7 days, to wit:

- 1) Negros Occidental Provincial Capitol
- 2) City Hall, Bacolod City
- 3) Port Management Office – Negros Occidental/Banago/Bacolod-BREDCO Bulletin Board
