

## **BAC Resolution Declaring LCRB and Recommending Approval**

## **RESOLUTION NO. EP001-2019**

WHEREAS, the Philippine Ports Authority, Port Management Office - Negros Occidental/Bacolod/Banago-BREDCO advertised the Invitation to Bid of the REPAIR OF MAIN ENTRANCE GATE, Port of San Carlos, San Carlos City, Negros Occidental (NRP-NBB-05-19) with an ABC of Php6,694,639.66, posted in the Philippine Ports Authority website, the PhilGEPS and in the conspicuous places at the following premises continuously for 7 days, to wit:

- 1) Negros Occidental Provincial Capitol
- 2) City Hall, Bacolod City
- 3) Port Management Office Negros Occidental/Banago/Bacolod-BREDCO Bulletin Board

WHEREAS, in response to the said advertisements, Only One (1) Bidder is interested and submit the bid documents and was found eligible during the opening of bids on December 17, 2019 with the following offer:

To declare HHH DEVELOPER AND CONSTRUCTION as the Bidder with the lowest Calculated Responsive Bid for the REPAIR OF MAIN ENTRANCE GATE, Port of San Carlos, San Carlos City, Negros Occidental;

- a) To award the Contract to HHH DEVELOPER AND CONSTRUCTION as the Contractor with the Single Calculated and Responsive Bid in the amount of SIX MILLION SIX HUNDRED EIGHTY THREE THOUSAND TWO HUNDRED EIGHTY EIGHT PESOS AND 35/100 (Php. 6,683,288.35), subject to existing rules and regulations; and
- b) To recommend for approval by the <u>Port Manager</u> of the <u>Philippine Ports</u> <u>Authority, Port Management Office Negros Occidental/Bacolod/Banago-BREDCO</u> the foregoing findings.
