BAC Resolution Declaring LCRB and Recommending Approval

RESOLUTION NO. RM-2018-01

WHEREAS, the *Philippine Ports Authority* advertised the Invitation to Apply for Eligibility and to Bid of the **Proposed Repair of Damaged Concrete Pavement at Portion of Area "I", Port of Cagayan de Oro** in a newspaper of nationwide general circulation and posted the same in the *Philippine Ports Authority* website, the G-EPS and a conspicuous place at the premises of the *Philippine Ports Authority* continuously for 7 days;

WHEREAS, in response to the said advertisements, **Seven (7)** contractors submitted letters of intent and purchased bid documents, namely; **JMT Construction, Jejor's Construction Corporation, LGC Trucking & Construction, Edanna Construction, JC Dela Vega Construction & Supply, Teddie Construction Development Inc., & LAJ Trucking & Builders Inc.;**

WHEREAS, **Seven (7)** bids were submitted on **June 20, 2018** namely: **JMT Construction, Jejor's Construction Corporation, LGC Trucking & Construction, Edanna Construction, JC Dela Vega Construction & Supply, Teddie Construction Development Inc., & LAJ Trucking & Builders Inc.** however, only **four (4)** passed the preliminary examination of bids;

WHEREAS, the detailed evaluation of bids conducted on **June 21, 2018** resulted in the following:

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the Bidder with the Lowest Calculated Bid, **JMT CONSTRUCTION**. was found to be responsive with all the requirements on this bidding;

If the BAC determines that the bidder with the Lowest Calculated Bid passes all the criteria for post-qualification, it shall declare the said bidder as the bidder with the Lowest Calculated Responsive Bid, and the head of the Procuring Entity concerned shall award the contract to the said bidder. (IRR-A Section 34.3) The TWG, with the assistance of the Secretariat, if necessary, shall prepare the BAC Resolution declaring the LCRB.


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


- a) To declare the bid of **JMT CONSTRUCTION** , as the Lowest Calculated Responsive Bid for the **Proposed Repair of Damaged Concrete Pavement at Portion of Area "I"** , Port of Cagayan de Oro; with bid amount of **Twenty Eight Million Four Hundred Eighty Six Thousand Seven Hundred Forty Four & 64/100 pesos only (28,486,744.64);**
- b) To respectfully recommend to the Head of Procuring Entity to award the contract for this bidding to **JMT CONSTRUCTION** & the Corresponding Issuance of the Notice of Award.

BAC Resolution Declaring Lowest Calculated Bid

WHEREAS, the Philippine Ports Authority, Port Management Office of Cagayan de Oro, through its Bids and Awards Committee for Engineering Projects, advertised and published/posted the Invitation to Bid for the Repair of Damaged Concrete Pavement at portion of Area "I", Port of Cagayan de Oro in a newspaper of nationwide general circulation, PPA Website and PhilGEPS as well as in the PPA PMO-CDO bulletin board on May 30, 2018.

WHEREAS, in response thereto, Seven (7) prospective bidders submitted their letter of intent and purchased bid documents, namely:

1. Edanna Construction
2. LAJ Trucking and Builders, Inc.
3. Teddie Construction
4. LGC Trucking and Construction
5. JMT Construction
6. J.C. DELA VEGA Construction & Supply
7. JEJOR's Construction Corporation

WHEREAS, during the Submission and Opening of Bids conducted on June 20, 2018 at 10:00 o'clock in the morning at the PPA, PMO-MO/C Building#2, GAD Hall, Port Area, Agora, Lapasan, Cagayan de Oro City, the same seven (7) bidders submitted their bid proposal on-time, namely:

1. Edanna Construction
2. LAJ Trucking and Builders, Inc.
3. Teddie Construction
4. LGC Trucking and Construction
5. JMT Construction
6. J.C. DELA VEGA Construction & Supply
7. JEJOR's Construction Corporation

WHEREAS, after the conduct of preliminary bid evaluation and the deliberation by the BAC with the assistance of the Technical Working Group (TWG), only four (4) passed the preliminary examination of the technical and financial envelope, namely;

1. LAJ Trucking and Builders, Inc.
2. LGC Trucking and Construction
3. JMT Construction
4. JEJOR's Construction Corporation

WHEREAS, the technical and financial envelopes and the Bid Amounts (as read) was rated “PASSED” and declared “ELIGIBLE”, as follows:

WHEREAS, the BAC has instructed the TWG to conduct bid evaluation to the eligible bidders pursuant to Section 32 Rule IX of the Revised Implementing Rules and Regulation of R.A. 9184;

WHEREAS, after conducting the detailed bid evaluation of the Bid proposal using the non-discretionary criteria in considering the completeness of the bid and to review for any arithmetical corrections, the TWG has disclosed the corrected bid amounts (as calculated), as follows:

WHEREAS, after conducting the detailed bid evaluation of the Bid proposals using the non-discretionary criteria in considering the completeness of the bid and to review for any arithmetical corrections, the TWG has recommended to the BAC that the bid proposal of JMT Construction be declared as *Lowest Calculated Bid (LCB) in the amount of Twenty Eight Million Four Hundred Eighty Six Thousand Seven Hundred Forty Four and 64/100 (P28,486,744.64).*

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby adopts the said recommendation of the TWG and declares **JMT Construction** as the bidder with the Lowest Calculated Bid (LCB) in the amount *Twenty Eight Million Four Hundred Eighty Six Thousand Seven Hundred Forty Four and 64/100 (P28,486,744.64).* Further, the Technical Working Group (TWG) is hereby DIRECTED to subject the Bidder with the LCB to Post Qualification Evaluation under Rule X of the Revised Implementing Rules and Regulation of R.A. 9184 in order to determine whether or not the bidder concerned complies with and is responsive to all the requirements and conditions as specified in the Bidding Documents in this Procurement Project. Said post qualification process must be completed in not more than seven (7) calendar days from receipt thereof, subject to an extension of said period upon the approval of the Head of Procuring Entity, but in no case shall the aggregate period exceed thirty (30) calendar days.
