

A RESOLUTION DECLARING THE PUBLIC BIDDING FOR CONTRACT FOR THE SUPPLY, DELIVERY, INSTALLATION/STRUCTURED CABLING, TESTING AND COMMISSIONING OF LED FLAT SCREEN TVS' WITH WIRES AND ACCESSORIES FOR THE BASEPORT CAGAYAN DE ORO, PORT MANAGEMENT OFFICE OF MISAMIS ORIENTAL/CAGAYAN DE ORO, (PMO MO/C), A "2ND FAILURE", AND TO ADOPT NEGOTIATED PROCUREMENT

WHEREAS, an Invitation to Bid and complete set of Bidding Documents was posted at PPA and PhilGEPS Website dated July 1, 2019, for the "re-bidding" of the project re: Contract for the Supply, Delivery, Installation/Structured Cabling, Testing and Commissioning of LED Flat Screen Television Sets with Wires and Accessories for the Baseport Cagayan de Oro, Port Management Office of Misamis Oriental/Cagayan de Oro (PMO-MOC;

WHEREAS, the Port Management Office of Misamis Oriental/Cagayan de Oro Bids and Awards Committee (PMO-MOC-BAC) convened on July 8, 2019, to conduct a Pre-bid Conference to ensure compliance with the standards set forth in Sec. 22 of the Revised IRR of RA 9184;

WHEREAS, four (4) bidders have attended the conference, namely: a) Microtrade GCM Corp., b) Saver-Tech Computer Sales & Services, c) Dataworld Computer Center, and d) Neotech Asia Inc.;

WHEREAS, out of the four (4) bidders who attended, only two (2) of them bought the bidding documents, namely: a) Microtrade GCM Corp., and b) Saver-Tech Computer Sales & Services. However, another two (2) bidders bought the bidding documents, but have not attended the Pre-bid Conference, namely: a) Ace Logic Computer Solutions, and b) Trends & Technologies Inc.;

WHEREAS, during the Opening of Bids, conducted on July 22, 2019, only two (2) bidders submitted their bid, namely: a) Ace Logic Computer Solutions, and b) Saver-Tech Computer Sales & Services. It may be noted however, that one (1) bidder submitted its Bid late, hence, it was not accepted;

WHEREAS, during the preliminary examinations of the two submitted bids, Ace Logic Computer Solutions was found to be non-complying, therefore, declared by the BAC as "INELIGIBLE", hence, only the bid of Saver-Tech Computer Sales & Services was subjected for a Detailed Bid Evalution;

WHEREAS, on July 25, 2019, during the meeting for the TWG report on the Result of their Detailed Bid Evaluation, it was found out that Saver-Tech Computer Sales & Services failed to meet the minimum requirement for the SLCC, as stated in Item 5.4 of the Bid Data Sheet:

WHEREFORE, in consideration of the foregoing, the *PMO-MOC-BAC RESOLVED AS IT IS HEREBY RESOLVES* to declare this bidding a "Failure" for the 2nd time pursuant to Sec. 35 of the Revised Implementing Rules and Regulation of RA 9184;

RESOLVED FURTHER, to respectfully recommend to the Port Manager as Head of the Procuring Entity (HOPE) to resort to Alternative Mode of Procurement thru Negotiated Procurement in consonance with Section 53.1 of the Revised IRR of RA 9184.

RESOLVED UNANIMOUSLY on July 25, 2019 at the GAD Hall, PMO Bldg. 2, Agora Gate, Port Area, Cagayan de Oro City.
