**WHEREAS**, the Philippine Ports Authority, Port Management Office of Cagayan de Oro, through its Bids and Awards Committee, advertised and published/posted the Invitation to Bid for the **Supply of Labor, Equipment & Materials for the Repair of Security Barricades**, Port of Cagayan de Oro in the PhilGEPS as well as in the PPA PMO-MOC bulletin board on August 10, 2023.
