A RESOLUTION DECLARING THE BID OF WORKER'S VISION MANPOWER SERVICES INC., (WVMSI) AS THE SINGLE CALCULATED AND RESPONSIVE BID FOR THE PUBLIC BIDDING OF THE CONTRACT FOR THE PROVISION OF TECHNICAL AND ADMINISTRATIVE PERSONNEL FOR THE PORT MANAGEMENT OFFICE OF MISAMIS ORIENTAL/CAGAYAN DE ORO (PMO MO/C) CY 2017, AND BE RECOMMENDED FOR THE AWARD OF THE CONTRACT

## Resolution No. 26, Series of 2016

(Excerpt from the Bids and Awards Committee – for Procurement of Goods and Services (BAC-PGS) Meeting on 09 December 2016)

WHEREAS, an Invitation to Bid was posted at PPA and PhilGeps Website dated 16 November 2016, for the procurement of the Contract for the Provision of Technical and Administrative support Personnel for the Port Management Office of Misamis Oriental/Cagayan de Oro, CY 2017;

WHEREAS, during the Opening of Bids dated 05 December, only the Bid of WVMSI was duly received by the BAC-PGS, and subsequently, rated Passed and declared Eligible per BAC-PGS Resolution No. 23, Series of 2016 dated 05 December 2016:

WHEREAS, in BAC-PGS Resolution No. 25. Series of 2016 dated 07 December 2016, the Bid of WVMSI with a calculated bid price of Twelve Million One Hundred Twenty-One Thousand Six Hundred Thirty-Nine & 44/100 Pesos (Php. 12,121,639.44) in Philippine Currency, is declared as the Single Calculated Bid;

WHEREAS, BAC-PGS has instructed the Technical Working Group (TWG) to conduct a post-qualification thereto in order to determine if the said bidder complies and/or is responsive to all the requirements and conditions specified in the Bidding Documents pursuant to Sec. 34 of the 2016 revised IRR of RA 9184, and to submit a report before the former on or before 09 December 2016;

WHEREAS, in a written Report dated 09 December 2016, the TWG has recommended to BAC-PGS that the Bid Proposal of WVMSI with a calculated bid price of Twelve Million One Hundred Twenty-One Thousand Six Hundred Thirty-Nine & 44/100 Pesos (Php. 12.121.639.44) in Philippine Currency, was found to be compliant and responsive to all the conditions and requirements specified in this bidding, and hence, has recommended that said bidder be awarded with the said contract;

WHEREFORE, in consideration of the foregoing, the BAC-PGS RESOLVED AS IT IS HEREBY RESOLVES to adopt and approved the recommendation of the TWG, and declares that the Bid of WVMSI with a calculated financial proposal in the amount of Php 12,121,639.44 as the Single Calculated and Responsive Bid.





**RESOLVED FURTHER** to respectfully recommend to the Port Manager/Hope that the Contract for the Provision of **T**echnical and Administrative Support Personnel for Port Management Office of Misamis Oriental/Cagayan de Oro be awarded to Workers Vision Manpower Services Inc., and that a Notice of Award be issued for this undertaking pursuant to Sec. 37 of the 2016 Revised IRR of RA 9184.

**RESOLVED FINALLY** to instruct the Secretariat to prepare all pertinent documents particularly the draft contract to be submitted to the General Manager thru the AGM for Finance and Administration as provided under the recently approved Revised Delegation of Authority of PPA for approval.
