BAC Resolution Declaring LCRB and Recommending Approval

RESOLUTION NO. 64

WHEREAS, the *Philippine Ports Authority* posted the Invitation to Apply for Eligibility and to Bid of the *Rewiring of Shorebased Power Supply, Port of Benoni, Camiguin* in the *Philippine Ports Authority* website, Philgeps, G-EPS and conspicuous place at the premises of the *Philippine Ports Authority* continuously for 7 days;

WHEREAS, in response to the said advertisements, Only One (1) contractor purchased bid documents, namely: *Lions Convergence Construction & Development*;

WHEREAS, *Lions Convergence Construction & Development* submitted its bid on *November 19, 2019* and passed the preliminary examination of bid, thus;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the technical and financial requirements submitted by the Bidder with the Single Calculated Bid, *Lions Convergence Construction & Development*, was found to be responsive with all the requirements on this bidding;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare the bid of *Lions Convergence Construction & Development*, as the single Calculated & Responsive Bid for the *Rewiring of Shore Based Power Supply, Port of Benoni, Camiguin* with calculated bid amount of Two Million Eight Hundred Twelve Thousand One Hundred Seven & 27/100 pesos only (P2,812,106.27);
- b) To respectfully recommend to the Head of Procuring Entity to award the contract for this bidding to *Lions Convergence Construction & Development* & the Corresponding Issuance of the Notice of Award.
