### BAC Resolution Declaring LCRB and Recommending Approval

#### RESOLUTION NO. 65

WHEREAS, the *Philippine Ports Authority* posted the Invitation to Apply for Eligibility and to Bid of the *Repair/Replacement of Security Lights along North-East Perimeter Fence and CCTV at Operational Areas, Port of Cagayan de Oro, Cagayan de Oro City* in the *Philippine Ports Authority* website, Philgeps, G-EPS and conspicuous place at the premises of the *Philippine Ports Authority* continuously for 7 days;

WHEREAS, in response to the said advertisements, Only One (1) contractor purchased bid documents, namely: *Khan Kon Chi Construction & Development Corporation*;

WHEREAS, *Khan Kon Chi Construction & Development Corporation* *Lions Convergence Construction & Development* submitted its bid on November 19, 2019 and passed the preliminary examination of bid, thus;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the technical and financial requirements submitted by the Bidder with the Single Calculated Bid, *Khan Kon Chi Construction & Development Corporation*, was found to be responsive with all the requirements on this bidding;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare the bid of *Khan Kon Chi Construction & Development Corporation*, as the single Calculated & Responsive Bid for the *Repair/Replacement of Security Lights along North-East Perimeter Fence and CCTV at Operational Areas, Port of Cagayan de Oro, Cagayan de Oro City* with calculated bid amount of *Nine Million Eight Hundred Thirty Three Thousand Nine Hundred Nineteen & 54/100 pesos only (P9,833,919.54)*;

(IRR-A Section 34.3) The TWG, with the assistance of the Secretariat, if necessary, shall prepare the BAC Resolution declaring the LCRB.*



- b) To respectfully recommend to the Head of Procuring Entity to award the contract for this bidding to *Khan Kon Chi Construction & Development Corporation* & the Corresponding Issuance of the Notice of Award.
