BAC Resolution Declaring LCRB and Recommending Approval

RESOLUTION NO. 66

WHEREAS, the *Philippine Ports Authority* posted the Invitation to Apply for Eligibility and to Bid of the *Repair of Damaged 128 l.m. RC Deck and 2 units Roro Berth Along Berth 3-5, Port of Cagayan de Oro, Cagayan de Oro City* in the *Philippine Ports Authority* website, Philgeps, G-EPS and conspicuous place at the premises of the *Philippine Ports Authority* continuously for 7 days;

WHEREAS, in response to the said advertisements, **Six (6)** contractors purchased bid documents, namely: *ZET Construction, JMT Construction, Jacinto Gerona Construction, LAJ Trucking Builders Inc., KHAN KON CHI Construction & Development Corporation & JC Dela Vega Construction*;

WHEREAS, Five (5) bids were submitted on *November 19, 2019* namely: *ZET Construction, JMT Construction, Jacinto Gerona Construction, LAJ Trucking Builders Inc., & KHAN KON CHI Construction & Development Corporation* however only three (3) contractor passed the preliminary examination of bids, thus;

WHEREAS, the detailed evaluation of bids conducted on *November 20, 2019* resulted in the following:

WHEREAS, upon post-qualification or careful examination, validation and verification of all the technical and financial requirements submitted by the Bidder with the lowest Calculated Bid, *ZET Construction* was found to be responsive with all the requirements on this bidding;

- b) To respectfully recommend to the Head of Procuring Entity to award the contract for this bidding to *ZET Construction* & the Corresponding Issuance of the Notice of Award.
