Whereas, after the **POST QUALIFICATION EVALUATION PROCESS** on the proposals of the **LOWEST CALCULATED BIDDERS (LCB)**, for the following: **Project 1. PROGRESS HOME & OFFICE FURNISHINGS**, **Project 2. COMFAC CORPORATION** and **Project 3. PROJECT MANAGEMENT & TECHNICAL RESOURCES, CORP.**, it was found out that they complied with all the requirements for the Post Qualification as **Lowest Calculated Responsive Bidder** for the projects per PMO LNI BAC Resolution No. 8B-2021 dated November 23, 2021.
