

## BAC Resolution Declaring LCRB and Recommending Approval

### BAC - RESOLUTION NO. 07a-2023 esd

WHEREAS, the Philippine Ports Authority, PMO-Misamis Occidental/Ozamiz, Port of Ozamiz, Ozamiz City send Request for Quotation (RFQ) to Three (3) Bidders of known qualification and posted the RFQ through Negotiated Procurement (Small Value Procurement, 53.9) of the Upkeeping/Cleanliness/Maintenance of Port Facilities for the period of Six (6) Months Port of Ozamiz, Ozamiz City in the Philippine Ports Authority (PPA) website, the PhilGEPS site and a conspicuous place at the premises of the Philippine Ports Authority, PMO-MOZ, Admin. Bldg., Ozamiz City continuously from the date of posting on September 05, 2023 until September 08, 2023;

WHEREAS, in response to the said request for quotation and advertisement, only One (1) contractor purchased the documents and subsequently, submitted his bid on September 08, 2023 at 2:00 P.M.;

WHEREAS, during the opening of bids on September 08, 2023 at 2:00 P.M. it was found out that the said Contractor with known qualifications passed the preliminary examination;

WHEREAS, the Approved Budget for the Contract (ABC): NINE HUNDRED SEVENTY THOUSAND NINE HUNDRED FIFTY FIVE AND 28/100 PESOS (Php 970,955.28) and the Contractor's bid is as shown below:

WHEREAS, upon review of all the requirements submitted by DBP Services Corporation, its bid has been found to be responsive;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:



RESOLVED, at the Philippine Ports Authority, Port of Ozamiz, Ozamiz City this 11th day of September 2023.


