

BAC Resolution Declaring LCRB and Recommending Approval

WHEREAS, the Philippine Ports Authority, PMO-MOZ, Port of Ozamiz, Ozamiz City sends a Request for Quotation (RFQ) to at least Three (3) Bidders and posts the RFQ through Negotiated Procurement (Small Value Procurement, 53.9) of infrastructure for the Repair/Improvement of Port Police Building, Port of Ozamiz, Ozamiz City, in the Philippine Ports Authority (PPA) website, the PhilGEPS site and a conspicuous place at the premises of the Philippine Ports Authority, PMO-MOZ, Admin. Bldg., Ozamiz City continuously from the date of posting on October 21, 2023, until October 24, 2023;

WHEREAS, in response to the said request for quotation and advertisement, only Two (2) contractors purchased the documents and subsequently, submitted their bid on October 24, 2023 at 10:00 A.M.;

WHEREAS, during the opening of bids on October 24, 2023, at 2:00 P.M. it was found out that the said Contractor passed the preliminary examination;

WHEREAS, the Approved Budget for the Contract (ABC): Php 997,495.93 and the Contractor's bid is as shown below:

WHEREAS, upon detailed evaluation of bids conducted on October 27, 2023, it was found out that J. C. Dela Vega Construction & Supply has the Lowest Calculated Bid.

WHEREAS, upon post-qualification or careful examination, validation, and verification of all the requirements submitted by J. C. Dela Vega Construction & Supply, its bid has been found to be responsive;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


