



BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

ONE (1) LOT SUPPLY, DELIVERY AND INSTALLATION OF FOUR (4) UNITS PHOTOCOPIER MACHINES FOR USE OF PPA, PMO ZAMBOANGA

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply, Delivery and Installation of Four (4) Units Photocopier Machines for Use of PPA, PMO Zamboanga on August 2 to 9, 2021 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the BAC sent Request for Quotations (RFQ) to three (3) suppliers, namely 1.) AU Trading; 2.) Philcopy Corporation, and 3.) Copylandia Office Systems Corporation. Out of the three (3) suppliers, only Philcopy Corporation submitted their price quotations. Photopro Trading & General Merchandise Company which participated through PhilGEPS website also submitted their bid through electronic mail.

WHEREAS, the BAC opened the sealed price quotation of the said suppliers on August 9, 2021 at 2:00PM. The results were detailed below:



To recommend for approval by the Port Manager of the PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.


