"DECLARING RRJ BEM CONSTRUCTION, INC. AS THE SINGLE CALCULATED BIDDER FOR THE PROJECT ROUTINE MAINTENANCE OF PORT PHYSICAL FACILITIES PROJECT 2023 PACKAGE 2: (1) REPAIR AND REPAINTING OF WALKWAY SHED AND GUARDRAILS FROM MAIN GATE TO POWERHOUSE, INFRONT OF PHIL AM HALL AND GSO AREA; (2) REPAINTING OF CYCLONE FENCE AT POWERHOUSE; (3) REPAINTING OF ELEVATED WATER TANK INCLUDING REPAIR OF PIPE BRACKET SUPPORT, PORT OF GENERAL SANTOS, MAKAR WHARF, GENERAL SANTOS CITY"

WHEREAS, The Philippine Ports Authority (PPA), PMO SOCSARGEN posted/published the Invitation to Bid for the project "ROUTINE MAINTENANCE OF PORT PHYSICAL FACILITIES PROJECT 2023 PACKAGE 2: (1) REPAIR AND REPAINTING OF WALKWAY SHED AND GUARDRAILS FROM MAIN GATE TO POWERHOUSE, INFRONT OF PHIL AM HALL AND GSO AREA; (2) REPAINTING OF CYCLONE FENCE AT POWERHOUSE; (3) REPAINTING OF ELEVATED WATER TANK INCLUDING REPAIR OF PIPE BRACKET SUPPORT, PORT OF GENERAL SANTOS, MAKAR WHARF, GENERAL SANTOS CITY" with an Approved Budget for the Contract (ABC) of Nine Hundred Sixty-Nine Thousand Ninety-Nine Pesos and 88/100 Only (Php969,099.88) Inclusive of 5% VAT;

WHEREAS, the said Invitation to Bid was posted at the PhilGEPS, PPA Websites and at the PMO SOCSARGEN's Bulletin Board in accordance with the Revised Implementing Rules and Regulations (IRR) on Republic Act (RA) 9184;

WHEREAS, in response to the said posting requirement, three (3) bidders procured the bidding documents namely: (1) MCS Builders, (2) RRJ BEM Construction, Inc., and (3) Winch Mechanical Innovations & General Construction, Inc.;

WHEREAS, a set of observers including a representative from COA was duly invited to the Pre-Bid Conference, Opening of Bids, and Post-Qualification activities;

WHEREAS, on the Pre-bid Conference conducted, the bidding documents containing the eligibility requirements, technical and financial components of the bid were discussed, clarified, and explained to prospective bidders;

WHEREAS, before the deadline of the submission of bids, there were three (3) bidders who successfully dropped its bid on time, namely: (1) MCS Builders, (2) Winch Mechanical Innovations & General Construction, Inc., and (3) RRJ BEM Construction, Inc.;

WHEREAS, on the scheduled opening of bids, the BAC conducted a preliminary examination of bids using the checklist of required documents and following the non-discretionary "pass/fail" criterion in accordance with Section 30.1 and 30.2 of the Revised IRR of RA 9184;

WHEREAS, after the preliminary examination of bids, the BAC ascertained and rated the following bidders:

- a) To declare RRJ BEM Construction, Inc. as the Single Calculated Bidder for the project "ROUTINE MAINTENANCE OF PORT PHYSICAL FACILITIES PROJECT 2023 PACKAGE 2: (1) REPAIR AND REPAINTING OF WALKWAY SHED AND GUARDRAILS FROM MAIN GATE TO POWERHOUSE, INFRONT OF PHIL AM HALL AND GSO AREA; (2) REPAINTING OF CYCLONE FENCE AT POWERHOUSE; (3) REPAINTING OF ELEVATED WATER TANK INCLUDING REPAIR OF PIPE BRACKET SUPPORT, PORT OF GENERAL SANTOS, MAKAR WHARF, GENERAL SANTOS CITY" with the bid amount of Nine Hundred Sixty-Seven Thousand One Hundred Forty-Eight Pesos and 82/100 Only (Php967,148.82) Inclusive of 5% VAT;
