**WHEREAS**, in response to the said posting, one (1) bidder procured the bidding documents, namely MCS Builders;

WHEREAS, the said bidder successfully dropped its bid on time;

WHEREAS, on the scheduled opening of bids, the BAC conducted a preliminary examination of bids using the checklist of required documents and following the non-discretionary "pass/fail" criterion in accordance with Section 30.1 and 30.2 of the Revised IRR of RA 9184;

WHEREAS, after the preliminary examination of bids, the BAC ascertained and rated the following bidders:
