**“A RESOLUTION DECLARING DEZMAR CONSTRUCTION AND DEVELOPMENT
AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE
PROJECT REPAIR OF DAMAGED DRAINAGE SYSTEM TO PROVIDE BOX
CULVERT, PORT OF GENERAL SANTOS, MAKAR WHARF, GENERAL SANTOS
CITY”**

WHEREAS, The Philippine Ports Authority (PPA), PMO SOCSARGEN posted/published the Invitation to Bid for the project *REPAIR OF DAMAGED DRAINAGE SYSTEM TO PROVIDE BOX CULVERT, PORT OF GENERAL SANTOS, MAKAR WHARF, GENERAL SANTOS CITY* with an Approved Budget for the Contract (ABC) of **Nine Million Three Hundred Eight Thousand Eight Hundred Sixty Pesos Only (P 9,308,860.00) Inclusive of 12% VAT**;

WHEREAS, the said Invitation to Bid was posted at the PhilGEPS, PPA Websites and at the PMO SOCSARGEN's Bulletin Board;

WHEREAS, in response to the said posting requirement, six (6) bidders procured the bidding documents namely Freden Construction, A.I. Yu Builders & Enterprises, Dumalag Surveying & Engineering Services, Dezmar Construction & Development, RS Lorenzo Construction and Megablue Konstrak Corporation;

WHEREAS, six (6) bidders successfully dropped its bid on time;

WHEREAS, during the opening and evaluation of bids, four (4) bidders failed in the Eligibility and Technical Requirements, namely: Freden Construction, Dumalag Surveying & Engineering Services, RS Lorenzo Construction and Megablue Konstrak Corporation;

WHEREAS, a Motion for Reconsideration dated July 20, 2018 was filed by Freden Construction;

WHEREAS, the BAC, after its deliberation, denied the said request for reconsideration of Freden Construction in a Resolution No. 07-EP dated July 20, 2018 which was duly received by the latter on July 23, 2018;

WHEREAS, in a Resolution No. 08-EP Series of 2018 dated July 20, 2018, the BAC declared Dezmar Construction & Development as the Lowest Calculated Bidder;

WHEREAS, a corresponding post qualification was conducted by the Bids and Awards Committee and Technical Working Group (TWG) of the BAC on July 21 to 24, 2018;


WHEREAS, the TWG, during the July 25, 2018 meeting of the BAC, reported its validation and confirmation of the legal, technical and financial requirements submitted by Dezmar Construction & Development;


NOW, THEREFORE, We, the members of the BAC, **RESOLVED** as it is hereby **RESOLVED**:


- a) To declare Dezmar Construction & Development as the Lowest Calculated and Responsive Bidder for the project *REPAIR OF DAMAGED DRAINAGE SYSTEM TO PROVIDE BOX CULVERT, PORT OF GENERAL SANTOS, MAKAR WHARF, GENERAL SANTOS CITY* with the bid amount of Seven Million Eight Hundred Seventy-Eight Thousand Three Hundred Eighty-Six Pesos and 51/100 (**Php7,878,386.51**) inclusive of 12% VAT;
- b) To recommend to the Head of the Procuring Entity for the approval of the said findings and issuance of the Notice of Award without prejudice to Section 55, 56 and 57 of the 2016 IRR of R.A. No. 9184.

RESOLVED, at the Philippine Ports Authority, PMO SOCSARGEN this 25th day of July 2018.


