“A RESOLUTION AUTHORIZING CORRECTION OF THE BID AMOUNT IN THE NOTICE OF AWARD (NOA) FOR THE PROJECT: ROUTINE MAINTENANCE OF PORT PHYSICAL FACILITIES PROJECT 2023 PACKAGE 4: 1. REPAINTING OF RC CURBS, BOLLARDS AND MARKING OF CALIBRATION POINTS FROM 000 TO 090 AT THE PORT OF GLAN; 2. REPAIR OF DAMAGED CONCRETE PAVEMENT INCLUDING REPAIR OF CRACKS ON CAUSEWAY OF PORT OF GLAN; 3. REPAINTING OF GATES, GUARDHOUSE, CHB FENCE AND CYCLONE FENCE AT THE PORT OF GLAN, GLAN SARANGANI PROVINCE”

WHEREAS, the bidding process for the Project Routine Maintenance of Port Physical Facilities Project 2023 Package 4: 1. Repainting of RC Curbs, Bollards and Marking of Calibration Points From 000 To 090 at The Port of Glan; 2. Repair of Damaged Concrete Pavement Including Repair of Cracks on Causeway of Port of Glan; 3. Repainting of Gates, Guardhouse, CHB Fence and Cyclone Fence at the Port of Glan, Glan Sarangani Province” has been completed;

WHEREAS, the project was awarded to the winning bidder, Leighcheen Construction Corporation;

WHEREAS, a corresponding Notice of Award (NOA) was issued to Leighcheen Construction with a contract price amounting to **One Million Ninety-Two Thousand Six Hundred Seventy-Eight Pesos and 13/100 (Php. 1, 092, 678.13)**;

WHEREAS, the said NOA was received by Leighcheen on July 27, 2023;

WHEREAS, it was found out that the amount provided in the NOA is different from the amount provided in the Bid Evaluation which is **One Million Ninety- Two Thousand Six Hundred Seventy - Four and 73/100 (Php. 1, 092, 674.73)**;


WHEREAS, the amount in the bid evaluation is the correct amount as a contract price for the said project;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:
