WHEREAS, the request for project: Emergency Repair of PSD Office at Port Operations Building which was damaged by Fire on May 31, 2021, Port of General Santos, Makar Wharf, General Santos City, was recommended by PMO-SOCSARGEN-BAC (PMO-SG-BAC) to resort to procurement under Negotiated Procurement for Emergency Cases and was subsequently approved by the Head of the Procuring Entity (HOPE) as recommended per BAC Resolution No. 003-2021;

WHEREAS, the PMO-SSG-BAC conducted the Negotiated Procurement under Emergency Cases and posted the Invitation to Bid at the PhilGEPS website on August 12, 2021;

WHEREAS, letters of invitation to make an official offer were sent to identified five (5) prospective bidders;

WHEREAS, in response to the said invitation, only one (1) bidder responded, namely the RRJ BEM Construction, Inc. and submitted its official offer;

WHEREAS, Section 2(b)ii under Annex H of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, states "that upon preparation of the appropriate procurement documents, the BAC may directly negotiate with the supplier, contractor or consultant with technical, legal and financial capability to deliver the goods, execute the works and perform the services to address the emergency. Upon confirmation and ascertainment of such capability to address the emergency, the HOPE, upon recommendation of the BAC, shall immediately award the contract to the Supplier, Contractor or Consultant"

WHEREAS, on August 19, 2021, the PMO-SSG-BAC conducted an Evaluation of Official Offer using a checklist of requirements as guide to ascertain the technical, legal and financial capability of the offeror to address the emergency;

WHEREAS, upon evaluation, with a rating of "PASSED", the PMO-SSG-BAC confirmed and ascertained the capability of the offeror to address the emergency;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To Declare RRJ BEM Construction Inc. as a the Single Winning Offeror;
- b) To Recommend to the Head of the Procuring Entity (HOPE) the Issuance of a Notice of Award for the project: Emergency Repair of PSD Office at Port Operations Building which was damaged by Fire on May 31, 2021, Port of General Santos, Makar Wharf, General Santos City
