WHEREAS, The Philippine Ports Authority (PPA), PMO SOCSARGEN posted/published the Invitation to Bid for the project"ROUTINE MAINTENANCE OF PORT PHYSICAL FACILITIES PROJECT 2023 PACKAGE 3: (1) WATERPROOFING OF ROOF DECK AT MAIN GATE; (2) REMOVAL OF CEILING, PAINTING OF CONCRETE ROOF SLAB, INSTALLATION OF NEW CEILING & SUPPORT, REPAINTING OF EXTERIOR/INTERIOR WALL OF GUARDHOUSE, AND ALUMINUM CLADDING AT MAINGATE, PORT OF GENERAL SANTOS, MAKAR WHARF, LABANGAL, GENERAL SANTOS CITY" with an Approved Budget for the Contract (ABC) of Seven Hundred Seventy-Four Thousand Six Hundred Forty-Seven Pesos and 15/100 Only (Php774,647.15) Inclusive of 5% VAT;

**WHEREAS**, in Resolution No. 23 Series of 2023, the BAC declared Leighcheen Construction Corporation as Single Calculated Bidder with Calculated Bid at Php**709**,**489**.**39**inclusive of 5% VAT;

WHEREAS, on September 13-14, 2023, the Technical Working Group (TWG) conducted the Post-Qualification in accordance with Rule X of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184;

WHEREAS, during Post-Qualification, the legal, technical, and financial documents under technical and financial components of the bid of Winch Mechanical Innovations, were verified, validated, and ascertained

**WHEREAS**, on September 15, 2023, the result of Post-Qualification was reported as having passed all the criteria of Post-Qualification and recommended by the TWG for the declaration of Single Calculated and Responsive Bidder;

**NOW, THEREFORE**, We, the members of the Bids and Awards Committee, hereby RESOLVED as it is hereby **RESOLVED**:

a) To declare Leighcheen Construction Corporation as the Single Calculated and Responsive Bidder for the project "ROUTINE MAINTENANCE OF PORT PHYSICAL FACILITIES PROJECT 2023 PACKAGE 3: (1) WATERPROOFING OF ROOF DECK AT MAIN GATE; (2) REMOVAL OF CEILING, PAINTING OF CONCRETE ROOF SLAB, INSTALLATION OF NEW CEILING & SUPPORT, REPAINTING OF EXTERIOR/INTERIOR WALL OF GUARDHOUSE, AND ALUMINUM CLADDING AT MAINGATE, PORT OF GENERAL SANTOS, MAKAR WHARF, LABANGAL, GENERAL SANTOS CITY" with the bid amount of Seven Hundred Nine Thousand Four Hundred Eighty-Nine Pesos and 39/100 Only (Php709,489.39) inclusive of 5% VAT;
