OF GENERAL SANTOS, MAKAR WHARF, GENERAL SANTOS CITY (RMP-SSG-01-
2022)”**

WHEREAS, on June 8, 2022, the first bidding was declared FAILURE by PMO-SOCSARGEN Bids and Awards Committee (PMO SOCSARGEN BAC) per BAC Resolution No. 006 -2022 dated June 8, 2022 for the project: Routine Maintenance of Port Physical Facilities Project 2022, Port of General Santos, Makar Wharf, General Santos City with Project Identification Number: RMP-SSG-01-2022

WHEREAS, on June 10, 2022, a Re-Invitation to Bid was posted in PhilGEPS and PPA websites;

WHEREAS, on June 30, 2022, 9:30 a.m., the BAC received no bid from any interested bidder until the deadline on the receipt and submission of bid as posted in the Re-Invitation to Bid;

WHEREAS, Section 35.1 of the 2016 Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184 states that *“The BAC shall declare the bidding a failure when: (a) no bids are received.. ”*;

WHEREAS, Section 53.1 of the RA 9184 provides that the BAC may resort to Negotiated Procurement under Two Failed Biddings as provided in Section 35 hereof;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To **DECLARE 2nd FAILURE OF BIDDING** under Section 35 (a) for the project: Routine Maintenance of Port Physical Facilities Project 2022, Port of General Santos, Makar Wharf, General Santos City;
- b) To **RESORT TONEGOTIATED PROCUREMENT** under Section 53.1of the above project subject to specific guidelines for Negotiated Procurement under Two-Failed Biddings as indicated in Annex H of RA 9184.
