WHEREAS, on September 28, 2022, an Invitation to Bid was posted in the PhilGEPS and PPA websites in accordance with Section 21.2 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184 for the Project: Routine Maintenance of Port Physical Facilities Project 2022 Package 1: 1. Repair and Repainting of G.I. Chains, Shackles and Accessories; 2. Retrieval of One (1) Unit Rubber Dock Fender, Port of General Santos, Makar Wharf, General Santos City;
