**“A RESOLUTION DECLARING WINCH MECHANICAL INNOVATIONS & GENERAL CONSTRUCTION, INC. AS THE SINGLE ELIGIBLE CALCULATED AND RESPONSIVE BIDDER AND RECOMMENDING ISSUANCE OF NOTICE OF AWARD (NOA) FOR THE PROJECT: ROUTINE MAINTENANCE OF PORT PHYSICAL FACILITIES PROJECT 2022 PACKAGE 1: 1. REPAIR AND REPAINTING OF GI CHAINS, SHACKLES AND ACCESSORIES; 2. RETRIEVAL OF ONE (1) UNIT RUBBER DOCK FENDER, PORT OF GENERAL SANTOS, MAKAR WHARF, GENERAL SANTOS CITY (RMP-SSG-01-2022)”**

**WHEREAS**, on October 20, 2022, the PMO-SOCSARGEN Bids and Awards Committee (PMO SOCSARGEN BAC) posted an Invitation to Bid in accordance with Section 21.2 of the 2016 Revised Implementing Rules and Regulations (IRR) on Republic Act (RA) 9184 for the Project: Routine Maintenance of Port Physical Facilities Project 2022 Package 1: 1. Repair and Repainting of GI Chains, Shackles and Accessories; 2. Retrieval of One (1) Unit Rubber Dock Fender, Port of General Santos, Makar Wharf, General Santos City;

**WHEREAS**, during the deadline of the receipt and submission of bid as posted in the Invitation to Bid which is on November 9, 2022, 9:00 a.m., two (2) the bidders dropped its bid within the prescribed deadline, stamped received by the Secretariat, and dropped in the Bid Box, to wit:

**WHEREAS**, on November 9, 2022, 9:30 a.m., the PMO-SOCSARGEN Bids and Awards Committee (PMO SOCSARGEN BAC) conducted the Opening and Preliminary Examination of Bids in the order of submission;

**WHEREAS**, the PMO SOCSARGEN BAC, opened and examined the Technical Component of the bid, containing the Legal, Technical, and Financial Documents, of the first bidder, Winch Mechanical Innovations & General Construction Inc. (WINCH), and was examined using the prescribed Checklist of Technical Documents;

**WHEREAS**, after examination and evaluation using the “pass-fail” criterion in accordance with Section 30 of the IRR of RA 9184, the Technical Component of the bid of WINCH was rated as “passed”;

**WHEREAS**, having passed the requirements under the Technical Components of the bid, the Financial Component of the bid of WINCH was opened and examined using the prescribed Checklist of Financial Documents;

**WHEREAS**, upon evaluation using the pass-fail” criterion of RA 9184, the Financial Component of the bid of WINCH was rated “passed” with its bid determined to be complete and patently sufficient at the Bid Amount of: One Million One Hundred Seventy-Four Thousand Three Hundred Ten Pesos and Sixty-Five Centavos (Php. 1,174,310.65) with a difference of One Hundred Forty-Two Thousand One Hundred Six Pesos and Thirty-Five Centavos (Php.142, 106.35) or 10.79% variance from the Approved Budget of the Contract (ABC) of One Million Three Hundred Sixteen Thousand Four Hundred Seventeen Pesos (Php.1,316,417.00);

**WHEREAS**, the PMO SOCSARGEN BAC, proceeded with the Opening and Preliminary of Bids of Technical Component of the bid of the second bidder RPE Engineering Procurement Construction, Management (RPE) using the prescribed Checklist of Technical Documents;

**WHEREAS**, after examination and evaluation using the "pass-fail" criterion in accordance of RA 9184, the bidder failed to include the Certificate of Acceptance as part of supporting documents as required under item (g) Statement of the bidder's Single Largest Completed Contract (SLCC) similar to the contract to be bid;

**WHEREAS**, having failed to comply with requirements under the Technical Components of the bid, bidder RPE Engineering Procurement Construction, Management, was rated "failed";

**WHEREAS**, the PMO SOCSARGEN BAC, immediately conducted a Detailed Bid Evaluation of the Technical and Financial Component of the bid of WINCH in accordance with Section 31 of RA 9184, as the Single Eligible Bidder or the only bidder who was rated "passed" for both components;

**WHEREAS**, after Bid Evaluation and determining the Single Calculated Bidder, WINCH, a Post-Qualification Evaluation was conducted in accordance of Rule X of RA 9184, on November 10-11, 2022 at Barangay Tumbler where the Office of WINCH is located;

**WHEREAS**, on November 14, 2022, during Post Qualification Report, the PMO SOCSARGEN BAC, having duly verified, validated, and ascertained the legal, technical, financial requirements of the bid, Winch Mechanical Innovations & General Construction, Inc, is determined to have passed all criteria of the Post Qualification and is recommended for declaration as Single Calculated and Responsive Bidder;

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To **DECLARE WINCH MECHANICAL INNOVATIONS & GENERAL CONSTRUCTION, INC.** as a **Single Calculated and Responsive Bidder** for the project: Routine Maintenance of Port Physical Facilities Project 2022 Package 1: 1. Repair and Repainting of GI Chains, Shackles and Accessories; 2. Retrieval of One (1) Unit Rubber Dock Fender, Port of General Santos, Makar Wharf, General Santos City (**RMP-SSG-01-2022**);
- b. To Recommend to the Head of the Procuring Entity (HOPE) the issuance of the Notice of Award.
