RESOLUTION NO. 15 -2016

WHEREAS, the Philippine Ports Authority, PMO-Zambo anga through its Bids and Awards Committee for the Procurement of Goods and Services (BAC-PG) in accordance with Section 52.1 (b)-Shopping of the Implementing Rules and Regulations (IRR) of Republic Act No. 9184 posted the Request for Quotation for the following:

WHEREAS, the Office required the suppliers to submit not later than December 9, 2016 at 2:00 P.M. their quotations enclosed in a sealed envelope with the following documents:

- 1. Duly accomplished PPA-Pregualification State Form;
- 2. Valid Mayor's Permit;
- 3. Certificate of Registration of Business Name (DTI/SEC or CDA);
- 4. BIR-VAT/Non-VAT Registration Certificate;
- 5. Latest BIR Income Tax Return;
- 6. Certificate of Philgeps Registration; and
- 7. Duly Accomplished Price Quotation Form Annex "A" (sealed in a separate envelope)

WHEREAS, the Office required that interested suppliers should have the complete documents as mentioned above. Quotations received in excess of the ABC shall be automatically rejected. It was made known to the suppliers that the above-mentioned lots shall be awarded to the one determined to have submitted the complete documents and with lowest price quotation;

WHEREAS, the Members of the BAC-PG together with the Technical Working Group (TWG), and the Secretariat attended the meeting during the Opening of Quotation held on December 9, 2016 at 2:00 P.M., at the Conference Room, Administrative Building, PPA, PMO-Zamboanga;

WHEREAS, the Chairperson of the BAC-PG, Emiliano M. Esparaguera, Jr., presided over the meeting and announced the opening of quotation for Item No. 1- One (1) Lot – Supply and Delivery of One (1) Unit DSLR Camera and One (1)Unit Underwater/Waterproof Camera, Brand new (ABC=Php 90,000.00);

WHEREAS, there were five (5) suppliers that were given the bid documents, namely: 1) Z.C LM Enterprises; 2) National Commercial; 3) Emcor Veterans; 4) R.C. Lim Marketing; and 5) Z.C. Paperline and Computer Stationers;

WHEREAS, of the five (5) suppliers that were given the bid documents, ONLY three (3) suppliers submitted their complete documents and were determined eligible suppliers. The price quotations of the three (3) suppliers are detailed below:

WHEREAS, upon careful examination, validation and verification conducted by BAC & TWG of all the technical and financial requirements submitted by the supplier with the Lowest Price Quotation, R.C. Lim Marketing, its bid was determined "Failed" for non-compliance with the required specifications;

WHEREAS, as a consequence, the BAC & TWG proceeded to examine, validate and verify all the technical and financial requirements submitted by the supplier with the Second Lowest Price Quotation, Z.C. LM Enterprises, its bid was determined "Passed";

WHEREAS, in view of the above-mentioned result, the BAC members <u>DECLARED</u> Z.C. LM Enterprises as the supplier with the Lowest Price Quotation and its bid has been found to be responsive;

WHEREAS, thereafter, the BAC-PG Chairperson announced the opening of quotation for Item No. 2-One (1) Lot – Supply and Delivery of Three (3) Units Air Condition Units, 2 HP, Window Type, Remote Control, Brand New (ABC=Php 135,000.00);

WHEREAS, there were five (5) suppliers that were given the bid documents, namely: 1) Z.C LM Enterprises; 2) National Commercial; 3) Emcor Veterans; 4) R.C. Lim Marketing; and 5) Ree Cooling Services;

WHEREAS, of the five (5) suppliers that were given the bid documents, ONLY three (3) suppliers submitted their complete documents and were determined eligible suppliers. The price quotations of the three (3) suppliers are detailed below:

WHEREAS, as a consequence, the BAC and TWG proceeded to examine, validate and verify all the technical and financial requirements submitted by the supplier with the Second Lowest Price Quotation, Z.C. LM Enterprises, its bid was determined "Passed";

WHEREAS, as a consequence of the above-mentioned result, the BAC members declared Z.C. LM Enterprises as the supplier with the Lowest Price Quotation and its bid has been found to be responsive;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby, RESOLVE, as it is hereby RESOLVED:

a) To declare Z.C. LM Enterprises as the Bidder with the Lowest Price Quotation for the following:

Item No. 1 One (1) Lot - Supply and Delivery of One (1) Unit DSLR Camera and One (1)Unit Underwater/Waterproof Camera, Brand new in the amount of Php \$9,995.00;

Item No. 2 One (1) Lot - Supply and Delivery of Three (3) Units Air Condition Units, 2 HP, Window Type, Remote Control, Brand New in the amount of Php101,940.00; and

b) To recommend for approval by the Port Manager of PPA, PMO-Zamboanga the foregoing findings.
