**RESOLUTION DECLARING LOWEST PRICE QUOTATION AND RECOMMENDING
APPROVAL**

RESOLUTION NO. 16 -2016

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga through its Bids and Awards Committee for the Procurement of Goods and Services (BAC-PG) in accordance with Section 53.9-Small Value Procurement of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 advertised/posted the Request for Quotation for the “One (1) Lot – Supply of Labor and Materials For the Fabrication of Various Office Furniture and Fixtures for PM’s Quarter and Traveler’s Hub, Port of Zamboanga”, in the PPA Website, PhilGEPS Website, and a conspicuous place at the Bulletin Board of PPA, PMO-Zamboanga from December 9-16, 2016;

WHEREAS, the BAC-PG required the suppliers to submit not later than December 19, 2016 at 10:00 A.M. their quotations enclosed in a sealed envelope with the following documents:

1. Duly accomplished PPA-Prequalification State Form;
2. Valid Mayor’s Permit;
3. Certificate of Registration of Business Name (DTI/SEC or CDA);
4. BIR-VAT/Non-VAT Registration Certificate;
5. Latest BIR Income Tax Return;
6. Certificate of Philgeps Registration; and
7. Duly Accomplished Price Quotation Form – Annex A (sealed in a separate envelope)

WHEREAS, the BAC-PG required that interested suppliers should have the complete documents as mentioned above. Quotations received in excess of the ABC shall be automatically rejected. It was made known to the suppliers that the above-mentioned lots shall be awarded to the one determined to have submitted the complete documents and with lowest price quotation;

WHEREAS, the Members of the BAC-PG together with the Technical Working Group (TWG), and the Secretariat attended the meeting during the Opening of Quotation held on December 19, 2016 at 10:00 A.M., at the Conference Room, Administrative Building, PPA, PMO-Zamboanga;

WHEREAS, the Chairperson of the BAC-PG, Emiliano M. Esparaguera, Jr., presided over the meeting and announced the opening of quotation for One (1) Lot – Supply of Labor and Materials For the Fabrication of Various Office Furniture and Fixtures for PM’s Quarter and Traveler’s Hub, Port of Zamboanga (ABC=Php 130,000.00);

WHEREAS, there were three (3) suppliers that were given the Request for Price Quotation (RFQ), namely: 1) Asiatic Trading Corporation; 2) Z.C. Filipinas Furniture; and 3) Mack’s Trading;

WHEREAS, of the three (3) suppliers that were given the RFQ, ONLY two (2) suppliers submitted their complete documents and were determined eligible suppliers. The price quotations of the two (2) suppliers are detailed below:

WHEREAS, upon careful examination, validation and verification conducted by the BAC-PG & TWG of all the technical and financial requirements submitted by the supplier with the Lowest Price Quotation, Z.C. Filipinas Furniture, its bid was determined "Passed";


NOW, THEREFORE, We, the BAC-PG, hereby, RESOLVE, as it is hereby RESOLVED:

- a) To declare Z.C. Filipinas Furniture as the Supplier with the Lowest Price Quotation for the One (1) Lot - Supply of Labor and Materials For the Fabrication of Various Office Furniture and Fixtures for PM's Quarter and Traveler's Hub, Port of Zamboanga in the amount of Php121,400; and
- b) To recommend for approval by the Port Manager of PPA, PMO-Zamboanga the foregoing findings.


