WHEREAS, the Philippine Ports Authority, PMO-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply and of Labor and Materials for the installation of Pipe-in Music at the Administration Building, PPA, PMO-Zamboanga, Zamboanga City starting November 25, 2019 to December 3, 2019 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;
