ONE (1) LOT – SUPPLY AND DELIVERY OF VARIOUS ELECTRICAL SUPPLIES & MATERIALS OF PPA, PMO-ZAMBOANGA

BAC-PG RESOLUTION DECLARING LOWEST PRICE QUOTATION AND RECOMMENDING APPROVAL

RESOLUTION NO. | 19 -2016

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga through its Bids and Awards Committee for the Procurement of Goods and Services (BAC-PG) in accordance with Section 52.1 (b)-Shopping of the Implementing Rules and Regulations (IRR) of Republic Act No. 9184 posted the Request for Quotation of "One (1) Lot – Supply and Delivery of Various Electrical Supplies & Materials of PPA, PMO-Zamboanga," at the Philippine Government Electronic Procurement System (PhilGEPS) Website, PPA Website and conspicuous place at the premises of the Philippine Ports Authority, PMO-Zamboanga from December 13-20, 2016;

WHEREAS, the BAC-PG required the suppliers to submit not later than December 21, 2016 at 2:00 P.M. their quotations enclosed in a sealed envelope with the following documents:

- 1. Duly accomplished PPA-Prequalification State Form;
- 2. Valid Mayor's Permit;
- 3. Certificate of Registration of Business Name (DTI/SEC or CDA);
- 4. BIR-VAT/Non-VAT Registration Certificate;
- 5. Latest BIR Income Tax Return;
- 6. Certificate of Philgeps Registration; and
- 7. Duly Accomplished Price Quotation Form Annex "A" (sealed in a separate envelope)

WHEREAS, the BAC-PG required that interested suppliers should have the complete documents as mentioned above. Quotations received in excess of the ABC shall be automatically rejected. It was made known to the suppliers that the above-mentioned lots shall be awarded to the one determined to have submitted the complete documents and with lowest price quotation;

WHEREAS, the Members of the BAC-PG together with the Technical Working Group (TWG), and the Secretariat attended the meeting during the Opening of Quotation held on December 21, 2016 at 2:00 P.M., at the Conference Room, Administrative Building, PPA, PMO-Zamboanga;

WHEREAS, the Chairperson of the BAC-PG, Emiliano M. Esparaguera, Jr., presided over the meeting and announced the opening of quotation for One (1) Lot — Supply and Delivery of Various Electrical Supplies & Materials of PPA, PMO-Zamboanga (ABC=Php 90,000.00). He announced that the scheduled second opening of quotation is an extension of the first opening held last December 9, 2016 for failure to obtain at least three (3) price quotations;

WHEREAS, there were three (3) suppliers that were given the bid documents in addition to the two (2) eligible suppliers who were considered during the said first opening. These are 1) Classique Enterprises; 2) Electron Comtronics & Service Center; and 3) Scepter Enterprises. All of the above-mentioned suppliers submitted their bid documents on time;

WHEREAS, The BAC-PG Chairperson requested the TWG to open the technical documents. After examination of the technical documents, all of the above-mentioned suppliers submitted their complete documents and were determined eligible suppliers;

WHEREAS, the BAC-PG proceeded to open the financial documents of the five (5) eligible suppliers and announced the price as detailed below:

WHEREAS, based on the above-quotations, the BAC-PG resolved to **declare Scepter Enterprises as the supplier with the Lowest Price Quotation** followed by Electron Comtronics & Service Center as the Second LPQ, Asiatic Trading Corporation as the Third LPQ, Classique Enterprises as the Fourth LPQ. However, RC Lim Marketing was automatically disqualified for quoting the amount of Php 97,320.00 which in excess of ABC =Php 90,000.00.

WHEREAS, based on the above-quotations, the original Enterprises were previously validated on October 10, 2016 for the procurement of "One (1) Lot – Supply and Delivery of Various Electrical and Other Hardware Supplies and Materials (PR #2016-275) and the result of the said evaluation is hereby adopted;

WHEREAS, upon careful examination, validation and verification of all the technical and financial requirements submitted by Scepter Enterprises, it has been found responsive;

NOW, THEREFORE, We, the Members of the BAC-PG, hereby, RESOLVE, as it is hereby RESOLVED:

- a) To **DECLARE** Scepter Enterpises as the Bidder with the Lowest Price Quotation for the One (1) Lot Supply and Delivery of Various Electrical Supplies & Materials of PPA, PMO-Zamboanga, in the amount of Php88,100.00; and
- b) To **RECOMMEND** for approval by the Port Manager of PPA, PMO-Zamboanga the foregoing findings.

RESOLVED, this <u>21st day of December, 2016</u> at the Conference Room, Administrative Building, PPA, PMO-Zamboanga, Zamboanga City.
