RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE PRICE QUOTATION AND RECOMMENDING APPROVAL FOR THE PROCUREMENT OF “ONE (1) LOT SUPPLY OF LABOR AND MATERIALS FOR THE INSTALLATION OF ONE (1) SET AUTOMATIC IDENTIFICATION SYSTEM (AIS) INCLUDING TESTING AND COMMISSIONING AT THE PSD-HARBOR, PPA, PMO-ZAMBOANGA”

RESOLUTION NO. 20 -2016

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga through its Bids and Awards Committee for the Procurement of Goods and Services (BAC-PG) in accordance with Section 53.9 – Small Value Procurement of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 advertised the Request for Quotation for One (1) Lot – Supply of Labor and Materials for the Installation of One (1) Set Automatic Identification System (AIS) including Testing and Commissioning at the PSD-Harbor, PPA, PMO-Zamboanga” from December 21-28, 2016 in the PPA Website, PhilGEPS Website, and conspicuous places of PPA, PMO-Zamboanga;

WHEREAS, the BAC-PG required the suppliers to submit not later than December 29, 2016 at 10:00 A.M. their quotations enclosed in a sealed envelope with the following documents:

1. Duly accomplished PPA-Prequalification State Form;
2. Valid Current Mayor’s Business Permit;
3. Certificate of Registration of Business Name (DTI/SEC or CDA);
4. BIR-VAT/Non-VAT Registration Certificate;
5. Latest BIR Income Tax Return;
6. Certificate of Philgeps Registration; and
7. Duly Accomplished Price Quotation Form – Annex A (sealed in a separate envelope)

WHEREAS, the BAC-PG required that interested suppliers should have the complete documents as mentioned above and quotations received in excess of the ABC shall be automatically rejected. It was made known to the suppliers that the said lot shall be awarded to the one determined to have submitted the complete documents and with lowest price quotation;

WHEREAS, the BAC-PG together with the Technical Working Group (TWG), and the Secretariat attended the meeting during the third Opening of Quotation held on December 29, 2016 at 10:00 A.M., at the Conference Room, Administrative Building, PPA, PMO-Zamboanga;

WHEREAS, the BAC-PG Vice-Chairperson, Francisca Clarissa P. Dagoy, in the absence of Chairperson Emiliano M. Esparaguera, Jr., presided over the meeting and announced the opening of quotation for the One (1) Lot – Supply of Labor and Materials for the Installation of One (1) Set Automatic Identification System (AIS) including Testing and Commissioning” of PSD-Harbor, PPA, PMO-Zamboanga with an Approved Budget for the Contract (ABC) of Php 470,000.00;

WHEREAS, the BAC-PG Vice-Chairperson, announced that there were three (3) suppliers that were given the bid documents, namely: 1) Electron Comtronics and Service Center; 2) Phone Patch

Marketing; and 3) Asiatic Trading Corporation. Of the three (3) suppliers, only one (1) supplier, Electron Comtronics and Service Center, submitted the bid documents.

WHEREAS, the BAC-PG Vice-Chairperson requested the TWG to open the technical documents. After examination of the technical documents, Electron Comtronics and Service Center submitted the documents complete and was determined an eligible*supplier;

WHEREAS, the BAC-PG Vice-Chairperson requested the TWG to open the financial documents. After examination of the financial documents, the said supplier was determined compliant. The price quotation is Php 469,840.00 which is lower than the ABC of Php 470,000.00;

WHEREAS, upon careful examination, validation and verification of all the technical and financial requirements submitted by Electron Comtronics and Service Center, it has been found responsive;

NOW, THEREFORE, We, the Members of the BAC-PG, hereby, RESOLVE, as it is hereby RESOLVED:

- a) To declare Electron Comtronics and Service Center as the Bidder with the Single Calculated and Responsive Price Quotation for the procurement of One (1) Lot Supply of Labor and Materials for the Installation of One (1) Set Automatic Identification System (AIS) Including Testing and Commissioning at the PSD-Harbor, PPA, PMO-Zamboanga in the amount of Php469,840.00; and
- b) To recommend for approval by the Port Manager of PPA, PMO-Zamboanga the foregoing findings.
